AFFIDAVIT

I, JAMES SHORT, of 1435 Water Street, Kelowna, BC, civil servant, AFFIRM THAT:

1. I am a Bylaw Enforcement Officer for the City of Kelowna in this matter. I have personal knowledge of the matters hereinafter deposed to save and except where those matters are stated to be based on information and belief, and to such latter matters I verily believe the same to be true.
2. Since approximately June 2021, in the course of my duties as a Bylaw Enforcement Officer employed by the City, I have been attending Stuart Park, located at 1430 Water Street, Kelowna, BC ("Stuart Park"), to conduct inspections of ongoing bylaw violations in relation to the weekly "Freedom Rally" event hosted by the Respondents David Lindsay and an organization which calls itself "Common Law Education and Rights" ("C.L.E.A.R."), in contravention of the City's bylaws.
3. Stuart Park is a popular waterfront park in downtown Kelowna. The large plaza is a popular venue for public events in the summer months, and transforms into an outdoor skating rink in the winter. It is also home to the signature local public art piece, "Bear".

Below the Bear statute is a set of stairs with a large landing that is commonly used as a stage for public events.

4. On November 20, 2021, I visited the website <https://clearbc.org/>, where I saw advertisements for the weekly Freedom Rally event at Stuart Park. According to the "About Us" page on the website, the co-founder and spokesman of C.L.E.A.R. is David Lindsay. The website indicated that Mr. Lindsay organizes and leads the Freedom Rally every Saturday. Attached as Exhibit "A" to this Affidavit is a true copy of a screen shot that I took of C.L.E.A.R.'s website, which accurately reflects the appearance of the site that day.

Inspection on August 21, 2021

5. On Saturday August 21, 2021, at approximately 10:30 a.m., I attended Stuart Park in the course of my duties as a Bylaw Officer employed by the City, to monitor the Freedom Rally event that was advertised as taking place every Saturday at 12:00 p.m. No permit for the Freedom Rally had been applied for or issued under the City of Kelowna Parks and Public Spaces Bylaw, No. 10680, 2017 (the "Parks Bylaw") or any other bylaw.
6. At approximately 10:42 a.m., I observed a red Ford Explorer vehicle pull up and park in front of Stuart Park, with a man I recognized as Mr. Lindsay, the organizer of the Freedom Rally, in the passenger seat. Mr. Lindsay and the driver of the vehicle, Sepora Geyzen, unloaded two speakers, a generator, and signs from the back of the vehicle.
7. Constable Molinari and Constable Bouter of the RCMP then arrived at Stuart Park. At approximately 10:50 a.m., we approached Mr. Lindsay together and I advised him that protesting is allowed and the City has no issues with protesting, but that City Bylaws do not permit him to have amplified sound, a generator, to set up a tent, to sell merchandise, or to place sandwich board signs on the City sidewalk without a permit. Mr. Lindsay disagreed and advised us that he will proceed with his event as normal, which I took to mean including the listed activities in violation of the Bylaws.

8. I asked Mr. Lindsay for his identification, but he claimed not to have it. He verbally provided his name and date of birth, and a P.O. Box for an address. I was not able to hear the address, as he was speaking very quickly and mumbling, and at the same time a female person who appeared to be associated with Mr. Lindsay's event was yelling in my ear, asking how I can sleep at night and telling me that I should get a new job, in an apparent effort to prevent me from hearing Mr. Lindsay's information.
9. I returned to my vehicle, which was parked near Stuart Park. I observed Mr. Lindsay set up speakers on the plaza stage of Stuart Park, below the Bear statue, and sandwich board signs advertising a "Freedom Rally every Saturday at 12pm". A 10x10 temporary gazebo tent with signage labelled "C.L.E.A.R." was also set up near the stage. A true copy of 6 photographs which I took while in attendance at Stuart Park that day, showing Mr. Lindsay setting up, the speakers and signs set up on the plaza stage, other signs and the tent set up, are attached as Exhibit "B" to this Affidavit.
10. A crowd of approximately 40-50 people gathered around the stage over the next hour. At approximately 12:16 p.m., I heard a female person speaking into a microphone over the speakers which Mr. Lindsay had set up on the stage at Stuart Park. The speakers amplified her voice.
11. Attached as Exhibit "C" to this Affidavit is a true copy of a photograph that I took of the attendees at the Freedom Rally on this day.
12. Based on the unpermitted use of an electronic device to amplify speakers' voices, the set up of the tent, and the set up of signs that advertise the Freedom Rally event every Saturday, I was of the view that Mr. Lindsay and the C.L.E.A.R. group had been holding an event. As a result, I issued bylaw notices based on contraventions of section 7.3 of the City of Kelowna Good Neighbor Bylaw, No. 11500, 2018 (the "Good Neighbor Bylaw"), section 3.8 of the Parks Bylaw, and section 2.3.2 of the City of Kelowna Sign Bylaw, No. 11530, 2019 (the "Sign Bylaw").

13. After the speaking portion of the event, members of the C.L.E.A.R group proceeded to walk up and down Bernard Avenue and the Boardwalk with their signs, handing out pamphlets. Bernard Avenue was closed to vehicle traffic that day, but the C.L.E.A.R group obstructed pedestrian traffic by walking down the middle of the roadway and along the boardwalk.
14. At or around 1:05 p.m., Corporal Brodeur and I approached Mr. Lindsay in order to serve him with the bylaw notices. As we approached, Mr. Lindsay turned his back and walked away from us and toward the crowd of attendees. When we called out to Mr. Lindsay, he responded with, "I have nothing to say to Bylaws."
15. At or around 2:35 p.m., once the crowd from the event had largely dispersed, I approached Mr. Lindsay, handed him the bylaw tickets and advised him that he had been served. In response, the approximately 15 remaining participants of the Freedom Rally made several negative comments to myself and the RCMP officers before we left the area.

Inspection on September 25, 2021

16. On Saturday September 25, 2021, at approximately 11:00 a.m., I attended Stuart Park in the course of my duties as a Bylaw Officer for the City, and parked my Bylaws vehicle across the street in front of City Hall. No permit for the Freedom Rally had been applied for or issued under the Parks Bylaw or any other bylaw for that day.
17. Upon arriving, I observed Mr. Lindsay unloading a generator and two large speakers from a blue Chevy vehicle owned by a Mr. Leo Beauregard. These speakers were set up on a retaining wall beside the stairs to the plaza at Stuart Park, and the microphone was set up on the stairs, with cables run from the generator the speakers and creating a tripping hazard for users of the walkway.
18. I also observed Mr. Lindsay and a few other people set up a 10x10 tent that advertised the organization C.L.E.A.R. They also erected a sandwich board sign on the sidewalk that advertised the Freedom Rally taking place every Saturday at noon.

19. There were approximately 50 to 70 attendees at the Freedom Rally that day. I heard Mr. Lindsay and a guest speaker, who identified himself as Steve Merrill, speak over a microphone that was being amplified by the two large speakers that had been set up beside the stairs at Stuart Park.
20. Attached as Exhibit "D" to this Affidavit are true copies of 4 photographs I took of the setup of the Freedom Rally on this day, showing Mr. Lindsay and other individuals setting up and holding signs.
21. I issued bylaw notices and a letter to Mr. Lindsay based on his contraventions of section 7.3 of the Good Neighbor Bylaw, sections 3.41 and 3.8 of the Parks Bylaw, and section 2.3.2 of the Sign Bylaw on that date.

Inspection on October 9, 2021

22. On October 9, 2021, at approximately 10:40 a.m., I attended Stuart Park in the course of my duties as a Bylaw Enforcement Officer employed by the City and parked across the street from City Hall. No permit for the Freedom Rally had been applied for or issued under the Parks Bylaw or any other bylaw for that day.
23. Around 10:47 a.m., I observed Mr. Lindsay arrive at Stuart Park in gold Toyota vehicle, which was driven away after dropping him off. I observed Mr. Lindsay begin to set up a 10x10 tent with the C.L.E.A.R. logo written on it, a table with pamphlets and documents, and two large speakers connected to a generator.
24. Around 11:00 a.m., I observed 5 or 6 vehicles with Canadian flags and the word "Resistance" written on them drive past Stuart Park several times while honking. They drove westbound, turned around at the roundabout, then came back eastbound and again turned around at the roundabout. One of the vehicles, a red Ford F150 subsequently parked at Stuart Park. Three people unloaded boxes from the back of this vehicle, and took the boxes to another 10x10 tent that had been set up beside the C.L.E.A.R. tent in

Stuart Park. I also observed two plastic 3-drawer containers with what appeared to be clothing merchandise labelled "Resistance".

25. The Freedom Rally speeches began at approximately 12:15 p.m. that day. At the event, Mr. Lindsay introduced two guest speakers, and afterwards made speeches himself. I could hear the speeches amplified through the two large speakers that had been set up and connected to the generator. 60 to 80 people were in attendance at the event.
26. At or around 1:10 p.m., I observed Mr. Lindsay encourage attendees to pick up signs and head over to the Cactus Club restaurant to demonstrate a lack of support for the business due to vaccine passport requirements.
27. At or around 2:00 p.m., Mr. Lindsay announced that he would be doing a draw for everyone who entered for a cash prize. Mr. Lindsay also announced that in two weeks a big rally would be held, on October 23, 2021, and that they would be protesting down Bernard Avenue and into the City's downtown area.
28. Attached as Exhibit "E" to this Affidavit are true copies of 7 photographs that I took of the Freedom Rally setup and event on that day.
29. I issued bylaw notices to Mr. Lindsay based on contraventions of section 7.3 of the Good Neighbor Bylaw, and sections 3.3 and 3.8 of the Parks Bylaw for his actions that day.

Inspection on October 23, 2021

30. On October 23, 2021, at approximately 10:30 a.m., in the course of my duties attending another call as a Bylaw Enforcement Officer for the City, I drove past Stuart Park and observed that Mr. Lindsay was on site setting up for the Freedom Rally event. I observed two speakers, a microphone, and numerous posters set up around Stuart Park. No permit for the Freedom Rally had been applied for or issued under the Parks Bylaw or any other bylaw for that day.

31. At around 10:58 a.m., I returned to Stuart Park and observed a female singing into the microphone. Her voice could be heard amplified over the two speakers that were powered by a generator. I also observed that the C.L.E.A.R. tent had been set up, and a group of people were setting up another red 10x10 tent beside it. Beside the red tent, I observed a clothing rack, with clothing that had the phrase "the Resistance" written on it, apparently being offered for sale.
32. I observed around 300 attendees at the Freedom Rally event on this day. Three or four people other than Mr. Lindsay made amplified speeches, using the microphone and speakers. At around 2:00 p.m., the event attendees proceeded to march around the block on the roadway, obstructing traffic by walking down the middle of Water Street to Doyle Avenue, then on to St Paul Street, up to Bernard Avenue and then back down to Water Street, before returning to the stage area of Stuart Park. After the march, Mr. Lindsay announced that there would be a meet and greet, where attendees would have a chance to meet the guest speakers. I observed the event until approximately 2:30 p.m. that day.
33. Attached as Exhibit "F" to this Affidavit are true copies of 9 photographs that I took of the Freedom Rally that day.
34. I issued bylaw notices to Mr. Lindsay based on contraventions of section 7.3 of the Good Neighbor Bylaw, as well as sections 3.3 and 3.8 of the Parks Bylaw, for the infractions I observed that day.

Inspection on October 30, 2022

35. On Saturday October 30, 2021, at approximately 11:15 a.m., I attended Stuart Park in the course of my duties as a Bylaw Enforcement Officer for the City. No permit for the Freedom Rally had been applied for or issued under the Parks Bylaw or any other bylaw for that day. The City had issued a permit for another event at Stuart Park on that day. When I arrived, I observed Mr. Lindsay was speaking with City Bylaw Enforcement Officer Hogan about the other event that was booked at Stuart Park.

36. Mr. Lindsay asked why other people were still allowed in Stuart Park. I advised that Stuart Park is still open to people to come and go, but there cannot be two events at the same time, as it would cause conflict, and that the group with a lawful event permit takes precedence. I pointed out that there were no planned events happening at Kerry Park, located at 1480 Mill Street, on this day. Mr. Lindsay and two other individuals drove over to Kerry Park.
37. At or around 11:20 a.m., I attended at Kerry Park. On my arrival, I observed a generator set up on the stage in the middle of Kerry Park, two large speakers, several signs, and the 10x10 tent with the C.L.E.A.R. logo on it. A second blue 10x10 tent was also set up with chairs. I observed two banners set up on stage with the caption "The Resistance."
38. I also observed two tables set up with a red tablecloth, set up to sell The Resistance merchandise. They had several boxes and plastic drawer containers full of clothing, some of which was piled on the tables. At around 12:18 p.m., I observed a female person purchase a clothing item from the table.
39. At approximately 12:49 p.m., I heard Mr. Lindsay and a guest speaker's amplified voices over the speakers. I observed around 80 to 100 attendees at the Freedom Rally event on this day. At around 1:30 p.m., I observed Mr. Lindsay lead the group of attendees toward the highway for a march. Mr. Lindsay stated they will be protesting by walking the boardwalk to City park and walking towards Harvey Ave and Highway 97, and would protest out on the Highway for an hour.
40. Mr. Lindsay and the group of attendees then obstructed traffic by walking down the middle of Water Street to Doyle Avenue, then on to St Paul Street to Bernard Avenue, back down to Water Street, then to Highway 97 where they stood along the sidewalk and the median.
41. Attached as Exhibit "G" to this Affidavit are true copies of 14 photographs that I took of the Freedom Rally that day.

42. I issued bylaw offence notices to Mr. Lindsay based on the contraventions of sections 3.3 and 3.8 of the Parks Bylaw which took place that day.

Inspection on November 13, 2021

43. On November 12, 2021, I saw a poster advertising the Freedom Rally on the website Facebook. The poster states, "Rise Up Against the Vax Passport: Kelowna Freedom Rally, Stuart Park, 12:00 PM, Saturday Nov. 13, 2021." Attached as Exhibit "H" to this Affidavit is a true copy of the poster as it appeared on that website.
44. On November 13, 2021, at approximately 11:16 a.m., I attended Stuart Park with Senior City Bylaw Officer England, to conduct an inspection of the "Freedom Rally" event, in the course of my duties as a Bylaw Officer for the City. No permit for the Freedom Rally had been applied for or issued under the Parks Bylaw or any other bylaw for that day.
45. Upon my arrival, I observed Mr. Lindsay was on site setting up speakers. Mr. Beauregard's blue Chevy vehicle was present and contained the items for the event setup, and was parked against the yellow portion of the curb where parking is prohibited due to the Fire Hydrant. I advised Mr. Beauregard that he was not allowed to park there and that he needed to move his vehicle immediately. Mr. Beauregard argued that he was not done unloading. I advised Mr. Beauregard that this was not a loading zone and again that he must move his vehicle. The people helping him took everything out of the truck and placed it on the boulevard so that Mr. Beauregard could move the vehicle. Attached as Exhibit "I" to this Affidavit are true copies of two photographs of the Chevy parked at the curb and persons removing signs and event items from it.
46. At around 11:20 a.m., a male person approached the steps where Mr. Lindsay was setting up the microphones and speakers. The man was holding a sign that stated, "Screw Your Freedom." The male appeared to be protesting against the Freedom Rally. I saw several people from the Freedom Rally, including Mr. Lindsay, telling the man to leave, and I could hear the man screaming back at them, stating that he has as much right to be there as

- they do. A true copy of 2 photographs of this interaction which I took that day are attached as Exhibit "J" to this Affidavit.
47. RCMP members arrived at Stuart Park shortly thereafter. They did not remove any of the attendees, but stood on the side of Stuart Park to keep the peace.
 48. I observed that two large speakers, a microphone, the C.L.E.A.R. tent, as well as tables and pamphlets, had been set up. A woman arrived in a grey SUV and started unloading tables and chairs, which she set up with coffee and treats "by donation", and a sign that said "Heaven on Earth Church". She was invited by Mr. Lindsay to open the rally with prayer.
 49. At approximately 12:27 p.m., I observed Mr. Lindsay attend the stage and begin speaking into the microphone. Three other guest speakers also spoke that day.
 50. Mr. Lindsay ended the speeches by announcing that next Saturday, November 20, 2021, C.L.E.A.R. would be holding a "Mega Rally" at Stuart Park. He then asked everyone to pick up some signs and march down to the Highway, and they would stand along the Highway educating people. Then they were to march back to Stuart Park.
 51. Mr. Lindsay and a group of attendees proceeded to obstruct traffic by walking down the middle of the roadway on Water Street to Doyle Avenue, then on to St Paul Street, to Bernard Avenue and back down to Water Street into Stuart Park.
 52. Attached as Exhibit "K" to this Affidavit are true copies of 3 photographs that I took at the Freedom Rally that day.
 53. I issued a letter and bylaw notices to Mr. Lindsay based on contraventions of section 3.8 of the Parks Bylaw and section 7.3 of the Noise Bylaw which took place that day.

Inspection on November 20, 2021

54. I saw a poster on clearbc.org advertising the Freedom Rally Event, stating that a “Kelowna World Wide Rally” taking place at Stuart Park on November 20, 2021 from 11:30 a.m. to 3:00 p.m. Attached as Exhibit "L" to this Affidavit is a true copy of the advertisement.
55. On November 20, 2021, at approximately 11:08 a.m., I attended Stuart Park to conduct an inspection of ongoing violations in relation to the “Freedom Rally” event in the course of my duties as a Bylaw Enforcement Officer for the City. No permit for the Freedom Rally had been applied for or issued under the Parks Bylaw or any other bylaw for that day.
56. I observed Mr. Lindsay set up speakers at the plaza stage and conduct a sound test over a microphone. I observed that the “C.L.E.A.R.” tent had been set up prior to my arrival. A woman was unloading a table, chairs, and a sandwich board sign that stated “Heaven on Earth Church” from a grey Chevy vehicle. She then set up the table with coffee and treats.
57. I observed around 200 attendees at the Freedom Rally event on this day. I saw a yellow school bus that unloaded attendees at the event.
58. At or around 11:38 a.m., I observed the woman had set up the Church table attend the stage and play guitar and sing songs over the speaker system with amplified sound. She later stated over the microphone that Mr. Lindsay has been hosting the Freedom Rally at Stuart Park every Saturday since 2020.
59. At around 1:28 p.m., Mr. Lindsay came up on the stage and began speaking into the microphone. He stated that he is hosting a course on Zoom next Sunday about how to lay charges against employers who let their staff go for not getting vaccinated against COVID-19. Around 1:35 p.m., Mr. Lindsay directed everyone to grab a sign and start marching toward the Highway.
60. Mr. Lindsay and a group of attendees then proceeded to obstruct traffic by walking down the middle of the roadway on Water Street to Doyle Avenue, then on to St Paul Street, to

Bernard Avenue and back down to Water Street, then to Highway 97 where they stood along the sidewalk and median.

61. Attached as Exhibit "M" to this Affidavit are true copies of 8 photographs that I took at the event that day.
62. I issued a letter and Bylaw Offense Notices to Mr. Lindsay's address advising of his contraventions of sections 3.8 of the Parks Bylaw and section 7.3 of the Good Neighbor Bylaw that day.

Inspection on January 22, 2022

63. On January 21, 2022, I saw a poster on Facebook advertising a "Mega Freedom Rally" event being hosted at Stuart Park on January 22, 2022. I went to the website clearbc.org and found another poster advertising the Mega Freedom Rally. Under "Coming Events", the page listed details for the Mega Rally including speakers and stating that the event would include a "Kelowna downtown march and highway rally". Attached as Exhibit "N" to this Affidavit are true copies of 3 screenshots I took of each event poster and the event details on that day.
64. On January 22, 2022 at approximately 7:51 a.m., I attended Stuart Park and took 2 photographs of the empty park to depict how small the space is for an event the size of the Freedom Rally. Attached as Exhibit "O" to this Affidavit is a true copy of the photographs I took at that time. No permit for the Freedom Rally had been applied for or issued under the Parks Bylaw or any other bylaw for that day.
65. At approximately 10:34 a.m., I drove by Stuart Park in the course of my duties as a Bylaw Officer for the City. I observed Mr. Lindsay setting up speakers, microphones, and signs for the Freedom Rally. At approximately 10:50 a.m., I attended the second floor of the City Hall, from which I observed Mr. Lindsay and numerous others setting up the 10x10 "CLEAR" tent. I observed that that the event signs that had been set up were blocking the park benches and that the microphone and various flags were blocking the park stairs.

- Attached as Exhibit "P" to this Affidavit are true copies of 2 photographs I took of the Freedom Rally event set up, which show how the benches and stairs at Stuart Park are blocked.
66. Attached as Exhibit "Q" to this Affidavit is a true copy of 2 photographs I took of Mr. Lindsay, showing him sorting the signs out and placing them in the park.
 67. At approximately 11:40 a.m., I attended Stuart Park and observed people hanging up a banner sign on the temporary fencing that the City had erected to separate Stuart Park from the adjacent ice rink. Attached as Exhibit "R" to this Affidavit is a true copy of a photograph I took of this banner sign being put up.
 68. At approximately 11:44 a.m., I observed several vehicles driving past Stuart Park numerous times, while honking their horns. One of the vehicles had a sign on it that read, "The Resistance." The honking did not stop for several minutes, until all the vehicles had parked.
 69. I also observed two additional tents that had been set up beside the C.L.E.A.R. tent. People in one of the tents were handing out coffee to attendees, and people in the other tent were handing out pamphlets.
 70. I observed that the sidewalk was blocked by people attending the Freedom Rally, and the bike lane in the roadway was obstructed by attendees who were holding signs. Attached as Exhibit "S" to this Affidavit is a true copy of 19 photographs I took of the event that day, some of which show the blocked sidewalk and bike lane.
 71. At approximately 11:59 a.m., I saw a female wearing a red jacket playing a guitar and singing on stage through the microphone and speakers which amplified these sounds. I identified the singer as Jacquelyn Rose, as I had seen on the C.L.E.A.R website that the Freedom Rally event would be hosted by "singer/songwriter Jacquelyn Rose."
 72. At 12:10 p.m., I observed Mr. Lindsay speaking over the speaker system. Four other guest speakers spoke during the event, and Mr. Lindsay subsequently returned to direct event

participants to march several blocks in the surrounding area before heading down to Highway 97. Mr. Lindsay and a group of the attendees then proceeded to obstruct traffic by walking down the middle of the roadway on Water Street to Doyle Avenue, then on to St Paul Street, to Bernard Avenue and back down to Water Street, then to Highway 97 where they stood on the sidewalk and median.

73. I observed over 1,000 attendees at the Freedom Rally event that day.
74. I issued a letter and Bylaw Offense Notices to Mr. Lindsay's address for contraventions of sections 3.8 and 3.41 of the Parks Bylaw, section 2.4 of the Sign Bylaw, and section 7.3 of the Good Neighbor Bylaw that day.

Inspection on February 5, 2022

76. On February 5, 2022, I saw a poster on the website clearbc.org advertising the Freedom Rally event being hosted at Stuart Park on February 5, 2022. Attached as Exhibit "T" to this Affidavit is a true copy of the event poster.
77. On February 5, 2022, at approximately 10:35 a.m., I attended the second floor of City Hall, across from Stuart Park, in the course of my duties as a Bylaw Enforcement Officer for the City. From the window of City Hall, I observed that Stuart Park was empty at that time. No permit for the Freedom Rally had been applied for or issued under the Parks Bylaw or any other bylaw for that day.
78. At 10:42 a.m., I observed Mr. Lindsay and Mr. Beauregard arriving at Stuart Park in Mr. Beauregard's Chevy truck, which contained all the signs, speakers and generator for the Freedom Rally event. Mr. Beauregard typically brings Mr. Lindsay and these items to Stuart Park each Saturday around the same time. The two unloaded the speakers and signs from Mr. Beauregard's truck, and Mr. Lindsay set up the C.L.E.A.R. tent, a microphone, and speakers in the plaza area. They erected signs against cement benches and elsewhere throughout Stuart Park. Attached as Exhibit "U" to this Affidavit are true

copies of 9 photographs I took that day, depicting Mr. Beauregard and Mr. Lindsay unloading the truck and setting up these items.

79. At 11:12 a.m., I could hear several vehicles honking while they drove past the Freedom Rally.
80. At 11:15 a.m., I observed Mr. Lindsay test the volume of the speakers at the event. From where I was located at the City Hall, I could hear what Mr. Lindsay was saying through the microphone across the street.
81. At approximately 11:24 a.m., a series of vehicles began to drive by the Freedom Rally and honk their horns. I observed that the vehicles continued driving past and honking, non stop, for over three hours until approximately 2:45 p.m.
82. At approximately 12:30 p.m., Mr. Lindsay spoke through the microphone to give a five-minute warning of the event's official start, and at approximately 12:35 p.m., he began speaking in the microphone and continued to do so until approximately 1:05 p.m. After Mr. Lindsay completed his speech, the crowd started to break off.
83. I observed that approximately 400 people attended the Freedom Rally on this day. Once Mr. Lindsay stopped speaking, around 100 people continued to occupy the area around and along the roadway outside of Stuart Park. A tree cutting truck pulled over beside the park and the operator got into the bucket with a Canadian Flag and went up as high as the bucket could go.
84. At around 2:45 p.m., I attended at Stuart Park and required that the approximately 30 remaining persons in the roadway clear the area.
85. Attached as Exhibit "V" to this Affidavit are true copies of 17 photographs I took of the Freedom Rally that day, depicting Mr. Lindsay speaking and attendees obstructing sidewalks and the roadway. 44

86. I issued a letter and three Bylaw Offence Notices to Mr. Lindsay's address for contraventions of sections 3.8 and 3.41 of the Parks Bylaw, and section 7.3 of the Good Neighbor Bylaw that day.

Inspection on February 12, 2022

87. On or around February 12, 2022, at approximately 11:30 a.m., I attended the second level of City Hall with my colleague, Bylaw Enforcement Officer Black. From this vantage point, I saw two speakers, a microphone, and wires set up on the plaza stage in front of the bear statute at Stuart Park, as well as numerous political signs placed throughout Stuart Park. I also observed two 10x10 tents, as well as a table and chairs. All of these items appeared to be associated with the weekly Freedom Rally. No permit for the Freedom Rally had been applied for or issued under the Parks Bylaw or any other bylaw for that day.
88. I observed around 250 to 300 attendees at the Freedom Rally that day. Vehicles drove by Stuart Park continually honking their horns from around 11:30 a.m. to 2:30 p.m. I saw a large blue banner pinned to one of the vehicles that stated:
- "Truckers – Keep on Trucking
Convoy Support Rally
Kelowna, Canada."
89. I also observed several people on the roadway by Stuart Park, obstructing the bike lane, with flags and signs encouraging cars that were driving past to honk in support.
90. I further observed a man who I have seen protesting against the Freedom Rally on many Saturdays in front of City Hall. On this day, I saw him and seven other individuals who joined his protest. Throughout the event, I saw several attendees of the Freedom Rally, including Mr. Lindsay, approach and verbally attack him these eight individuals by insulting them and calling them names.
91. Mr. Lindsay spoke through the microphone and speakers on the plaza from about 12:00 p.m. to 12:30 p.m., At around 1:00 p.m., Mr. Lindsay got into the passenger seat of Mr. Beauregard's truck.

92. At around 2:30, approximately 30 people remained in the roadway. Bylaw Officer Black and I proceeded to direct the remaining individuals to clear Stuart Park and the roadway at that time.
93. Attached as Exhibit "W" to this Affidavit are true copies of 23 photographs that I took of the Freedom Rally event on that day, some of which show Mr. Lindsay and others speaking through the microphone, and individuals obstructing the sidewalk and roadway.
94. I issued a letter and three Bylaw Offence Notices to Mr. Lindsay's address, for contravention of sections 3.8 and 3.41 of the Parks Bylaw and section 7.3 of the Good Neighbor Bylaw that day.

Inspection on April 2, 2022

95. On April 2, 2022, at 10:26 a.m., I attended City Hall in the course of my duties as a Bylaw Officer for the City. Mr. Lindsay attended to set up and conduct the Freedom Rally as he has been doing each Saturday. No permit for the Freedom Rally had been applied for or issued under the Parks Bylaw or any other bylaw for that day. Attached as Exhibit "X" to this Affidavit are true copies of 15 photographs that I took of Mr. Lindsay and his supporters setting up for the Freedom Rally that day.
96. At 11:32 a.m., I observed a man who I identified as Mr. Thomas Kuntz unloading a banner, clothing rack, and table out of a blue Subaru Outback vehicle. He was assisted by another man to set up the clothing rack and table next to the C.L.E.A.R. tent which had been set up by Mr. Lindsay earlier that day for the weekly Freedom Rally. The banner that they set up in front of the table stated "VaccineChoiceCanada.com." At this table, Mr. Kuntz and others proceeded to offer items such as t-shirts and books, with a price list displayed on the table and labelled "Donation Gifts". Attached as Exhibit "Y" to this Affidavit are true copies of 8 photographs that I took of this table and items for sale.
97. Attached as Exhibit "Z" to this Affidavit are true copies of 6 photographs that I took of the Freedom Rally that day.

Inspection on April 23, 2022

98. I saw a post on Facebook by Bruce Orydzuk, posted on April 21, 2021, advertising a speaker at the Kelowna Mega Rally in Stuart Park on April 23, 2022 and stating "you don't want to miss this event!" Attached as Exhibit "AA" to this Affidavit is a true copy of a screenshot of that Facebook post which accurately depicts its appearance when I viewed it.
99. On April 23, 2022, at approximately 10:20 a.m., I attended the third floor of City Hall, from which I observed the Freedom Rally, in the course of my duties as a Bylaw Officer for the City. No permit for the Freedom Rally had been applied for or issued under the Parks Bylaw or any other bylaw for that day.
100. Around 10:22 a.m., I observed two males setting up a red tent. About 20 minutes later, Mr. Beauregard pulled up in his Chevy with the signs, speakers, a tent, and a generator for the Freedom Rally, and parked adjacent to the yellow curb that was within 5 meters of a fire hydrant. Mr. Lindsay and another man who I identified as Mr. Bruce Orydzuk were also in the vehicle. They got out and unloaded the Freedom Rally equipment from the truck.
101. I saw Mr. Lindsay proceed to hang a banner in front of the stairs at Stuart Park. He then set up a microphone in the middle of the plaza stage, blocking any use by the general public. Attached as Exhibit "BB" to this Affidavit are true copies of 6 photographs which I took that day, showing Mr. Lindsay and other setting up the Freedom Rally.
102. Around 11:05 a.m., another group arrived and set up a sandwich board sign for the heaven on Earth Church, as well as a table with coffee and baked goods for sale by donation.
103. At approximately around 11:20 a.m., I observed that two tables had been set up beside the C.L.E.A.R. tent. One of the tables had a Canadian flag hanging from it, and a sign taped to the table with a price list of the merchandise that was being sold at the table. Attached

- as Exhibit "CC" to this Affidavit are true copies of 2 photographs of the tables, merchandise and signs which I observed that day.
104. Additional tables were set up with flags, hats, t-shirts and merchandise which appeared to be offered for sale during the event. Attached as Exhibit "DD" to this Affidavit are true copies of 2 photographs of these merchandise tables.
 105. At around 12:21 p.m., I observed Mr. Lindsay come up to the microphone and begin speaking through it with amplified sound. A female person who I identified as Jacquelyn Rose came up and sang a few songs. Afterward, Mr. Lindsay continued to speak until around 1:00 p.m., and a guest speaker that I identified as Mr. Ted Kuntz spoke until 1:15 p.m. Another guest speaker then spoke until around 1:35 p.m. Attached as Exhibit "EE" to this Affidavit are true copies of 5 photographs showing Mr. Lindsay speaking at the Freedom Rally and the attendees at the event that day.
 106. At around 1:46 p.m., Mr. Lindsay returned to the stage and stated they would be doing a march down to the highway afterwards. A number of persons left with Mr. Lindsay and proceeded to obstruct traffic by walking down the middle of the roadway on Water Street to Doyle Avenue, then on to St Paul Street, to Bernard Avenue and back down to Water Street and then to stand and protest along Highway 97.
 107. I observed approximately 100 to 130 attendees at the Freedom Rally event on that day.
 108. On the same day, I issued a letter and three Bylaw Offence Notices to Mr. Lindsay's address for contravention of sections 3.8 and 3.41 of the Parks Bylaw, section 2.4.1 of the Sign Bylaw, and section 7.3 of the Good Neighbor Bylaw.
 109. As of the date I make this Affidavit, no permit has been issued or applied for in relation to the Freedom Rally event, and Mr. Lindsay continues to organize and conduct this event

at Stuart Park and on the City's public roadways every Saturday without a permit in contravention of the City's bylaws.
