1. I am a Security Analyst for the City of Kelowna in this matter. I have personal knowledge of the matters hereinafter deposed to save and except where those matters are stated to be based on information and belief, and to such latter matters I verily believe the same to be true.
2. On October 25, 2022, I accessed the recorded video from three of the City's downtown intersection traffic cameras, which video footage was taken on October 8, 2022. This footage is recorded and retained for a 30-day period in the usual and ordinary course of the City's business.

Attached as Exhibit "A" to this Affidavit is a true copy of a still frame I took from the traffic camera video at the intersection of Bernard Avenue and Ellis Street, which was recorded at approximately 12:53 PM on October 8, 2022.
