Update on last week's 4-day trial

Kelowna Courthouse

R v David Lindsay s. 266 Criminal Code Assault

After an incredible two days in court March 1st and 2nd, everyone finally got to see what the fuss is all about – and the shock even in the media was visible everywhere in the courtroom. Even opposition media, who came out in droves hoping to see some incredible fight scene to label me with, were amazed and dismayed at what truly occurred. The video, taken by one of our loyal supporters clearly showed that **THEY** (security guards) pushed into David, not the reverse. And more evidence is yet to come.

Now that everyone in the courtroom has seen the video of what really happened, even some media who were present were surprised at what occurred. I guess they were hoping for some wild fist fight that of course simply did not happen...as the video shows, THEY assaulted me.

Court trial update:

As everyone in court could see this past week, *"It ain't over."*

First, a wonderful and heartfelt thank you to all the wonderful freedom activists who came to watch four (4) grueling days of prosecutorial lies and judicial bias, many of whom also came from out of town. It wasn't easy watching what was happening and not being able to say anything...and I have been in that position far too many times so I understand fully this frustration. Thank you so much for your support!

Second, by way of short background. Back in August 2021, local health official Dr. Sue Pollock, who works out of the Interior Health (IH) building in downtown Kelowna, issued a mask order forcing everyone in the Interior to wear masks. We immediately began protests at the IH building. This drove them the nuts.

I went to reception in an attempt to have Dr. Pollock or some other official come down and answer our questions. On Aug. 4, 2021, I was told five (5) times that an official would come down, only to be told later, that no one was coming down.

On Aug. 11, 2021, I entered the IH building with Leo doing video recording to talk to the receptionist. IH security chief Greg (The Deceiver) Smith physically pushed (assaulted) Leo out of the building. I continued to talk to reception. By this time, I had no audio recording of what was transpiring because Leo was outside the building. He did however, get the events on video through the glass until I left the building a few minutes later. The video clearly shows me calmly talking to reception, the receptionist being calm at all times as myself, and no disturbance being caused. It was a polite discussion with reception at all times.

The Deceiver then informed more police who had arrived, that he wanted me banned from the building, and falsely accused a woman who was talking to security and another police officer, of threatening people and he wanted her banned as well, which Leo immediately told the cop The Deceiver was lying. No charges were laid against this woman for anything of course, and as if she is going to threaten people directly in front of the police.

Shortly after, while I was talking to a police officer, The Deceiver informed me that I was banned from entry for one (1) month, as a result of causing a disturbance that morning which, upon my demand to know the details of what I allegedly did to cause such a disturbance, he walked away without telling me, to no surprise. Nor did he tell the police anything I did that would support him banning me from the

IH building. The video from Aug. 11 clearly shows that I did not cause a disturbance nor do anything improper in the building. I'm grateful to Leo for all his videos!

The IH building is a privately owned building, leased to IH. The Charter applies to the BC Government, IH and The Deceiver as an agent of IH, as he later conceded on the witness stand.

My primary defence was that the security guards assaulted *me* in the exercise of my Constitutional right of access to peacefully walk into the IH building to discuss IH issues in relation to the masks issued by an IH official working in that building. Thus, it was critical for me to evidence that I caused no disturbance and The Deceiver had no power to ban me, thus no power to prohibit my entry, and he broke the law by assaulting me.

One week later on Aug. 19, when I attempted to walk in to talk to reception, the security guards blocked my entrance and assaulted me. The police then charged me with assault. I cannot go into too much legal details here, as I still have to make final submissions, as I note further below.

Court began on Tuesday morning May 23, 2021, with the Crown completing its examination of security guard Jason (The Liar) Davis, then with Palladin Security. The Liar gave evidence that yes, I did have a right of access, but this was revoked by The Deceiver. In the absence of this denial of access, pursuant to the *Trespass Act*, I would not have been stopped from entering the building and he confirmed again that I did have a right of access.

I played our Aug. 19 video that Leo had taken over and over for The Liar, and despite the video clearly showing that all three security guards pushed into me to stop me from entering, The Liar continued to claim I assaulted them. The Liar's entire defence rested on the alleged prohibition against me from entering the building.

Next up with The Deceiver, IH official **Greg Smith**.

The Deceiver, who admits to having been in court numerous times in the past and knowing how to give evidence in court, (ie: he knows how to lie professionally), was a consummate professional liar on the witness stand. The Deceiver took his entire time on the stand, either re-phrasing my questions to him, or professionally answering the question by answering with a non-responsive comment. Then when

asking for clarification, he would simply repeat his non-responsive answers, effectively ensuring that important evidence did not get on the record.

He repeatedly insisted that, notwithstanding his admission that he was bound by the Charter, he had the power to prohibit me from entering this Government occupied building for any or no reason at all, at his personal pleasure, anytime he wanted and I could not stop him. As a result, he was entitled, he claimed, to physically block my access and assault me if I attempted to enter the building.

Smith admits that he and staff had repeated meetings about how to stop our rallies outside the IH building, and myself especially from entering the building. His actions were clearly designed to protect IH officials inside the building from accountability to the public for their actions.

After playing the Aug. 19 video of the event to him, including in slow motion, he continued to deny that he blocked me at first. He finally had to admit, after many questions and re-phrasing of questions to his evasive answers and many video replays, that yes, he moved his arm from the door jam in front of his chest, and moved his upper torso to physically block me from entering. As did Jason Davis, another Liar. But he still claimed that I assaulted him by walking into him, despite the video evidence showing otherwise.

As opposed to mere cross examination, it became quite a heated debate, as I repeatedly told J. Heinrichs he was evading answer the questions and to order him to answer them as I put them to him. She refused to so do and just let The Deceiver witness control the cross examinations.

Next witness was Const. Ruitenbeck of the Royal Criminal Mounted Police. His evidence was generally fair, admitting that I was "*civil*" and respectful at all times. I was not screaming, swearing, yelling, threatening nor any other activities that would amount to causing a disturbance. But he was still prohibiting me from entry on the basis of The Deceiver's unsupported and non-verified allegations that he prohibited my access. Ruitenbeck conceded he did no investigation as his superior, Corporal Lobb, took over during our discussions.

Ruitenbeck admits that there was a man, 1-2 feet from myself and The Deceiver at all times, who had a bird's eye view of the events. In fact, he had the best view of this incident. But Ruitenbeck did not ask him for a statement or even check to see

who he was. Nor did Const. Goodwin who did the investigation. It should be noted that the RCMP only took information from police officers and IH officials. No attempt was made to get information from this direct witness to the events, from Leo who was doing the video also only 1-2 feet away, or myself or anyone else. It was a completely one-sided investigation. We know why that was don't we? Yup...if they submitted a Report to Crown Counsel with direct witnesses of the events contrary to the IH and police narrative, they would never get a conviction and most likely, not even a prosecution. So, they simply leave all of this critical evidence out of their investigation. That is how the police control what evidence gets into the hands of the Crown.

Next was Corp. Lobb, the supervisor. Lobb told me on Aug. 11 that she agreed with my position that I had a right of access to the IH building, and could go there every day of the week and discuss my concerns with the receptionist if I wished, as long as I did not cause a disturbance. She further conceded that she told this to The Deceiver as well.

The Crown attempted to get her to admit that she never had this power and thus it had no weight in law, despite her admissions that she told this to The Deceiver as well so he knew of this prior to his assault upon me and denying me my right of access.

All Corp. Lobb's actions in this regard, were all videoed on our Aug. 11 video recording. J. Heinrichs still refused to allow me to tender this into evidence and cross examine Lobb in relation to her actions on that date, despite Lobb's evidence on this same point being admitted into evidence orally.

On Thursday morning, I filed a Charter application that the actions by The Deceiver in prohibiting my access to the building, were a violation of my s. 2, 7 Charter rights and freedoms, as I told the Judge I would do on Wednesday. I was going to submit the Aug. 11 video as evidence. It was admittedly a rush job just to get it on the record, to permit the Judge to know I was going to pursue that avenue, now that the evidence supported it. I am entitled to amendments before any attempt to strike can be heard. The A.G. claimed it was deficient in certain facts which I agreed, due to being a rush job. J. Heinrichs still refused to allow me to amend it over the weekend, despite my agreement to waive any *Jordan* delay rights I had, claiming I should have filed it months prior, despite the fact the evidence was not on the record to support me so doing. I wanted it to get heard, period. Nope, she wouldn't

allow this Charter Challenge to be heard either.

The A.G. then acknowledged that she was going to oppose my RCMP challenge that the *RCMP Act* was unconstitutional as only the Province has the power to legislate in relation to policing in the Province, not the Feds.

Consequently, by this time on Friday afternoon, it was agreed two more days were required for final arguments and the A.G.'s motion to strike my Constitutional Challenge.

Folks this is now an eight (8) day trial on this falsified charge, plus many more appearance dates and a disclosure hearing in the past. Five police are involved, three security officials, and at least four prosecutors and their assistants. All to support the Gov't officials assaulting me to prevent the IH officials from being held accountable.

Judge Heinrich, who is completely biased in favour of the Crown, has let the Crown control this entire case from beginning to end. The Prosecutor, David Grabavac, objected to so many questions that I suggested he might as well just stay standing up. He continually interrupted the flow of my presentation and questions. Admittedly some questions were hearsay, but many were not and many were proper questions. I lost over 20 pages of questions due to the Judge's refusal to permit my Aug. 11 video into evidence, and her failure to advise me that I could have still played it for the witness.

I told J. Heinrich on the opening day of trial, that the way the courts screw people is to prevent the issues and arguments from coming on the record. If they are not there before the Court, the person loses. Or to deny witnesses and evidence from coming on the record and if that happens, the person loses as well, as a local lawyer here told me who was actively exposing serious corruption in the court system decades ago. Or they intentionally mischaracterize the issues, arguments and evidence to support an adverse judgment. I reminded her during the trial, when she prohibited my video evidence from Aug. 11 from being tendered into evidence, that this is exactly what she was doing. I knew the fix was in from the beginning of the trial.

There is much more important information I could add, however, as final arguments are still to come, I will have to keep my remaining points confidential until after the

next hearing dates at some point in the future.

I have an appointment on Wed. May 31, at 9:30 to set two more hearing dates for final submissions and for the A.G. to serve me its application to try and strike my RCMP challenge. Considering J. Heinrich's clear bias in favour of the Crown, appearing frequently it seems as a Gov't employee rather than an independent judge, I would not be surprised if this will be granted as well.

Thank you for all your support, despite having two enemies in the courtroom – the Crown and the Judge!

Update -- Petition to ban Kelowna Protest/Rallies

I now must begin to continue working on our reply to the Petition to ban our rallies. This is the biggest attempt to control our freedom of speech and assembly in history.

The media has already confirmed to me that they were instructed by the Gov't not to print anything contrary to the Gov't COVID-19 narrative. If they deny us our freedom to protest where it is most effective, then other cities will follow likewise by banning our protests, and without any media assistance, the Gov't will be free to do whatever it wants with no public exposure. Pure Communism. This is the most critical time in our struggle for freedom....right now.

I am now continuing to work on completing our reply to this Petition and have about two weeks or so remaining to complete it. This is a complicated response as many issues of law are involved, that require hundreds of hours of research and analysis before we file any documents. All documents and pleadings are now placed on our website for public viewing: <https://clearbc.org/city-of-kelowna/> Details of our position

cannot be released just yet, however it will be interesting to expose their corruption as we move along. **Once our responding materials are filed, we will post them on line as well.**

Unfortunately, this case will have significant repercussions for every protest rally in British Columbia, and indeed, in Canada, as it is being heard in a superior court in the province. This will be an incredibly complex case.

- Sign-up on the Newspaper Delivery list so that you get an email confirming the deliveries for each Sunday. With winter in mind, we will only do this if roads are bare and it's not snowing. The advantage of delivering this time of year is that nobody is hanging out in their front yards except for the odd snowman.
- We meet at the Capri parking lot between A&W and De Dutch Pannekoek House
 - Bring a large bag for carrying the papers if you want
 - Grab a free small Kelowna mapbook that can help you get situated. Your cell phone will be tracking and tracing you. Learn how to read maps again
 - You will be provided with a printed google map of the area you will be delivering to. Bring a yellow marker to indicate which streets you completed. You may run out of papers or you may end up with extra
 - We ask that with every paper you deliver, you remove the inserts and place them in the mailbox in front or behind the paper. That way, someone who may hastily throw out the paper will still be forced to see each individual flyer
 - Please deliver only one paper per mailbox, regardless if you have different papers (we usually have a combination of different papers and editions). Some houses may have up to 4 mailboxes; put one paper in each as they are for different tenants



- Sign up as a Volunteer to participate in one of the many focus groups we are working to organize. Most people are too busy to commit to fighting for freedom. 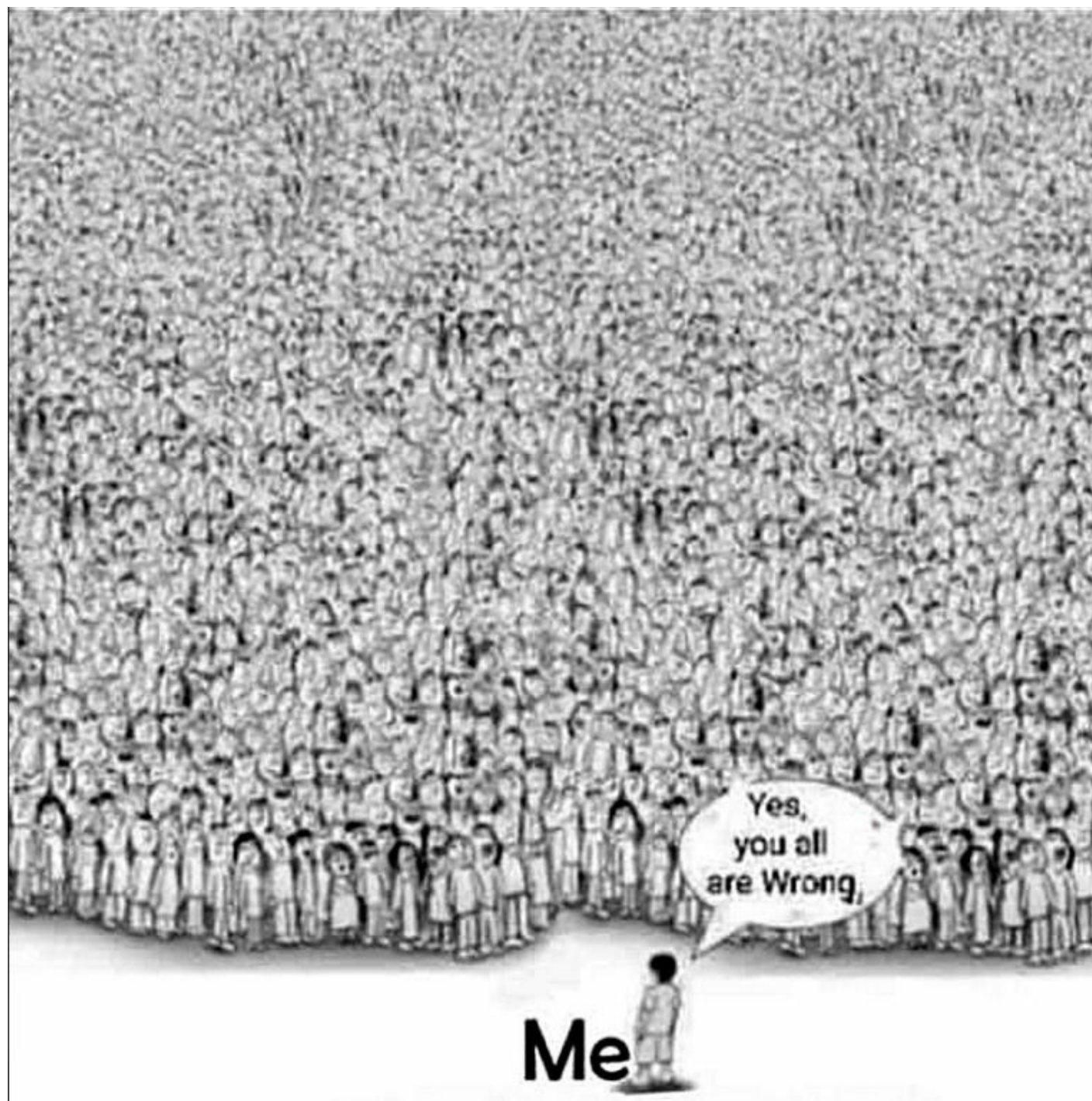
