I, Jacquelyn-Rose Jones, of the City of Vernon in the Province of British Columbia,

affirm and say that:

1. I am a woman affected by the relief sought in this case, and as such have personal knowledge of the facts herein deposed to by me, except where same is stated to be based on information and belief, in which case I do verily believe same to be true.
2. Beginning in March 2020, the provincial government of British Columbia began issuing recommendations to municipalities, including Kelowna, Vernon and the surrounding cities and towns, that I do verily believe infringed upon my constitutionally protected rights and freedoms.
3. Shortly afterwards, I began to notice that our public servants, began to intrude upon my constitutionally protected freedoms and choices by applying pressure to local businesses and municipal governing bodies to restrict my freedom of movement and freedom of speech and expression.
4. This caused me great concern as I personally witnessed businesses being threatened with legal action if they did not comply. Later, I became more concerned as I witnessed nurses and other professionals including government employees being terminated for refusing to subject themselves to the experimental injections. I honestly believe that this is the correct name, not vaccines, as these injections remained in the experimental stage until 2023.
5. I became further concerned and outraged when I began to read and hear about pastors and ministers being penalized if they refused to conduct their ministries in compliance with orders from the government and unelected bureaucrats. The Supremacy of God in our

world and our culture and in my heart are not subject to any government intervention. It is my belief that we are free to worship God in the manner of our own choosing here in Canada.

6. I was and am extremely concerned about the BC government and the City of Kelowna coercing my friends and neighbours and the good people of Kelowna to think and believe that a paper face covering could ever effectively protect them from an airborne virus many times smaller than the pores of a paper mask. I was deeply distressed to witness banks, grocery stores and businesses asking patrons to voluntarily restrict their ability to breathe by covering their beautiful faces. I felt sad and afraid for the health of my friends and neighbours breathing in recycled carbon dioxide.
7. Since March 2020, I personally witnessed a kind of insanity drape down over the consciousness of the people of British Columbia and beyond, that I met. I witnessed every department of our public servants obediently transgress upon the very elements which make a man or woman free including freedom of thought, freedom of conscious, freedom of speech, freedom of mobility, freedom to breathe, autonomy of the body, freedom to use Canadian legal tender, even freedom for our children to use public playground equipment. I was and remain to the present, extremely upset by these criminal acts inflicted upon myself and everyone else in B.C.
8. I believe from my research and reading, including from inspiring books I have read such as The Law by Frederick Bastiat, that freedom is always only one generation away from extinction, and it is my duty, living in a country with Constitutionally protected rights and freedoms, to take actions that I can do to halt any and all infringements upon my own right to live free, to live peacefully, and to make my own choices, and to support this for others.
9. I believe that the rights and freedoms we have, as fought and died for by our ancestors, require myself and others, to be responsible to take peaceful actions to protect them when they are at risk, or threatened, as was and is the situation in Canada today.
10. One such action that I have participated in from the beginning, has been my involvement in public protests such as at Stuart Park in Kelowna, in Vernon, and in Penticton, expressing my opposition to all government lockdowns, restrictions and mandates, to others and the public.
11. I have expressed myself by way of signs, my personal presence at these protests, and by my songs on stage, which I intended to inspire people with my messages to support our collective opposition to the government's actions in relation to COVID-19, and all threats to our rights and freedoms.
12. I attended the protests at Stuart Park to take responsibility for peaceful action to protect my rights and freedoms that I believe are being threatened.
13. Attending these protests permitted me to exercise my freedom of choice to publicly show my opposition to COVID-19 lockdowns and restrictions at all levels of government, and to demand actions from them to stop doing so.
14. I further wanted to assist in educating others and to hear and learn from other speakers and people in attendance who have knowledge and expertise that I do not. I received significant

benefits and education learning the truth of various issues in relation to COVID-19 and now in relation to ongoing threats to other rights and freedoms that I have, such as digital ID and currencies, and my loss of privacy associated with this.

15. Meeting and hearing from people on their experiences, including those injured victims of the experimental injections, those who have had their employment terminated for refusing to be injected with experimental drugs or for refusing to wear masks, those who watched loved ones die alone because they were not allowed to be with them in hospitals or in assisted living complexes, were very important to support myself and each other in this terrible situation. We were told by government to not gather together. Assembling at Stuart Park rallies enabled myself and others to support each other emotionally and socially which was and is essential to our mental health.
16. Our free choice to seek redress and accountability from municipal, provincial and federal public servants' decisions to infringe upon and abrogate our freedoms, by assembling together in Stuart Park, educating each other on various aspects of the treachery we have all experienced, sharing our experiences of brutal government encroachments on rights and freedoms, and supporting each other as we watched loved ones commit suicide, lose their jobs, and die suddenly after being forced to take an experimental injection, is incumbent upon us as responsible men and women.
17. Attending freedom rallies in Stuart Park across from Kelowna's City Hall to protest the breaches of Constitutional law committed by our public servants is essential for me to help correct the course of action our public servants have taken against the free will choices of myself and the men and women living and visiting here, who were also affected by these government actions.
18. As a singer/songwriter, I support freedom in Canada and in Kelowna by inspiring courage and education in my fellow Canadians through songs. Here is a sample of lyrics of two songs I wrote called Canada Rising and Canada United, specifically to be sung by myself at the Kelowna Freedom Rallies and Protests.

## **Canada Rising**

### **Chorus:**

We are Canada Rising. The true north strong and free  
We are Canada Rising. In brotherhood and liberty.

Vs: Every man and woman has the right to their own choice.  
To form their own opinions, the right to use their voice.  
To stand for truth and justice to express their own minds.  
Free will is essential for us to be kind.

Vs. Who are they that claim to know what's best for you and me?  
What's a legal fiction? Are you truly free?  
Does it obfuscate, obliterate, and take your rights at birth?  
Does the law protect what your soul is worth?

Vs The strength of human spirit comes from love and not from force

Morality's our compass – a gift from Source  
Censorship removes us from responsibility  
Here we stand on guard for liberty.

## Canada United

### Chorus:

We've got a long way to go, and 5 days to get there. Canada United we are free.  
From the East to the West, everybody's coming as truckers stand for law and liberty.

Vs Everybody's angry. Where do they get off, telling us that we should get a shot?

The government is lying. All the press is too, saying that they're doing this for you.

Vs All across the nation in the bitter cold Canadians are standing on the road.

I see their smiling faces saying Come along with me. Let's take back our country and be free.


Vs 18 wheelers rolling, four wheelers too. They're closing in on Ottawa for you.


They're driving for our freedom. They hold our Bill of Rights. Let's open up our hearts and shine our lights!

19. I have read the Petition filed in this case by the City of Kelowna. The by-laws quoted in the Petition filed by the City of Kelowna are subservient to my constitutionally protected freedoms of speech, mobility, and my duty to redress wrongs by public officials who are servants to us, the men and women living in British Columbia.
20. I find and believe that section 27 of said Petition particularly glaring in its inaccuracy: The City submits that there are no exceptional circumstances that would justify refusal of the injunction in this case, and the relief should be granted as sought.
21. It is my belief that the unprecedented lockdowns of and restrictions placed upon businesses and schools, forced isolation of the elderly and infirmed from their loved ones, government requirements that visitors to public buildings cover our faces and obstruct our ability to breathe, refusals of hospitals to treat men and women who refuse forced medical treatments, denial of my right to travel unless I permit experimental drugs to be injected into me or cover my face, proliferation of pornographic materials in elementary schools, planning to restrict movements of free men and women within and beyond Kelowna city limits to a 15 minute perimeter like a jail cell, implementation of 5G electromagnetic pulses harmful to all life on this planet, and the refusal of all levels of governments to address these deep infringements upon my rights and freedoms, all of which our protests at Stuart Park are as a result of and in response to, are indeed "exceptional circumstances". Such actions have never happened in my lifetime and necessitated my response in opposition to them.

- 22. I have attended a significant number of protests at Stuart Park. CLEAR rallies with David Lindsay and other speakers, educated and experts in their own fields, have been 100% peaceful for three years. at every such protest I have attended. Passersby were always welcome to listen and to educate themselves with the plethora of expert materials and resources available. No passersby are harassed nor pressured to educate themselves.
- 23. I have experienced a wonderful, loving, mature and courageous amalgamation of men, women and children attending the CLEAR rallies from around the province. I have experienced great joy at the expressions of freedom and the support we all show for each other throughout the tremendous difficulties these government infringements have caused. The rally participants are among the kindest and most friendly Canadians I have ever met.
- 24. Attending these rallies at Stuart Park was extremely important to me because they enabled me to assemble with like minded men, women and children and to support each other with hugs, knowledge, and shared experiences. I learned so much about so many aspects of rights and freedoms and how these are being infringed upon in so many areas of our lives. The quality of presenters, the spiritual bonding, the encouragement that together we can restore and preserve freedom, was and is very important to the quality of life in Kelowna and in Canada. I was so grateful for the opportunity to inspire and uplift my new friends and acquaintances with songs and spiritual messages of hope. I met people who nearly committed suicide because of loneliness until they came to a Kelowna Freedom Rally and had their hope and spirit restored.
- 25. I am extremely concerned if we are prohibited from having our rallies in downtown Kelowna as sought in the Petition, because that would mean that I now live in a total dictatorship with no regard for the value of human life and no respect for Canadian laws. If the City of Kelowna, the B.C. Government or Public Health Officer Bonnie Henry had responded to our concerns about breaches of our Bill of Rights and Constitution, if they had listened and cared about protecting freedom, if they would have engaged in public discourse about the specific items of concern at these Rallies such as the nature of viruses or what happens when you wear a mask or when you force children to use toxic chemical hand sanitizers, then I believe that the issues that cause the Stuart Park Freedom Rallies would become null and void. Rather than rely upon harmful legislation to silence the people of Kelowna, I believe it is critical for the City of Kelowna to listen and support its people. The only place in the City of Kelowna that I believe is most effective to protest government and city actions is directly across from City Hall, in the town square facility built for this purpose.
- 26. I make this Affidavit true and correct, supporting Freedom Rallies at Stuart Park in Kelowna, B.C., and in support of my opposition to the Petition, and for no improper purpose.
