I, Leo Beauregard, of the City of Kelowna, in the Province of British Columbia,

affirm and say that:

 I am one of the Respondents in this case and as such have personal knowledge of the facts herein deposed to by me, except where same is stated to be based on information and belief, in which case I do verily believe same to be true.

Attending the Lawful Protests

o

2. When I first started listening to B.C. Public Health Officer Bonnie Henry (Henry) on the news in relation to SARS-CoV-2 (COVID-19), I immediately observed that she failed to speak about natural immune-boosting means like nutrition, exercise, Vitamin C, D, etc., or the superiority of naturally acquired immunity from exposure to viruses. Her message, I discerned, was clearly promoting fear, helplessness and state dependency by forcing compliance to all her mandates and orders. I could not believe this non-elected official, who is not even my doctor or whom I did not believe had any training in viruses, was dictating how myself and others had to legally put the fate of our health into her hands without question.

3. In January of 2020, I had watched "Event 201" online at this URL: <u>https://centerforhealthsecurity.org/our-work/tabletop-exercises/event-201-pandemic-tabletop-exercise</u>

- 4. This was an October 19, 2019 videotaped simulation of how all levels of Government in U.N. countries, the W.H.O., various health authorities and media would coordinate with each other to repeat the same message to populations worldwide in order to convince the masses that we were in the midst of a deadly pandemic. Based on my observations of Bonnie Henry and other Government officials in relation to COVID-19, I do verily believe this video. Myself and others now have since been referring to this situation more accurately as a "*PLANdemic*".
- 5. I began to notice that Government demands were causing division between family and friends, including in my own family and circle of friends, especially in relation to lockdowns, compelled mask usage and later, mandatory vaccinations in order to work and participate in social life.
- 6. Because the mainstream media (which I refer to as MSM) was only repeating the Government narrative on the MSM news that I did see, I found that myself and others I knew who questioned the narrative were being dismissed as a "*Conspiracy Theorists*".
- 7. I personally witnessed in my interactions with people in the public, that they were becoming victims of what Dr. Malone now refers to as "*mass formation psychosis*," which I understand to believe means mass delusion, including by strategic use and repetitiveness of certain words. The Government, in my opinion based on my readings, watching and observations in public, was executing very sophisticated psychological warfare against the population and the majority of people were behaving as expected under the circumstances, which disturbed me significantly.
- 8. In June 2020, my spouse Linda Jackson, sent a detailed letter, which I helped to draft, to the Mayor and every Councilor at the City of Kelowna in relation to their COVID-19 lockdowns and restrictions, which was completely ignored by the City and its Councilors. I quickly realized that virtually every politician in Canada was ignoring warnings from people who did not trust the Government narrative in relation to COVID-19, and that this was a massive political issue, not medical.

Lindsay (David) and refer to them as the Lawful Protests, herein) at Stuart Park in relation to the opposition to the B.C. Government's COVID-19 lockdowns and restrictions, around November 21, 2020, as I was hoping to associate and assemble with others who shared my beliefs and opinions, and be able to express my same to the public.

- 10. David told me shortly after I starting attending the Lawful Protests, that he chose publicly to use the word "*rallies*" instead of the more correct word of "*protests*" because too many people have a negative viewpoint to this latter word, whereas the word "*rallies*" had a much more positive connotation to it. I agreed, but in my own mind, I fully considered these to be "*protests*" against all levels of Government, as myself and others were actually opposing what they were doing in relation to COVID-19.
- 11. I wanted to and was in the exercise at all times of my common law and s. 2 Charter rights and freedoms by attending the Lawful Protests as David also calls them and which I also agree with, also the Lawful Marches. I wished and was able to associate and connect with many other protestors and individual speakers at these Lawful Protests and share and receive more information from them, including what was happening on a local level.
- 12. Both myself and my spouse learned of these Lawful Protests from Messenger on Facebook. It was difficult to find out what was really happening around Kelowna with regards to opposition to the *PLANdemic* due to the censorship from all media sources. I had heard nothing in the MSM about these Lawful Protests nor any other opposition to the Government narrative or restrictions.
- 13. It was my belief and understanding from the beginning, that these Lawful Protests were to and did oppose the COVID-19 lockdowns and restrictions by all levels of Government. I strongly supported this and remain committed to this cause today, especially as all levels of Government continue to profess that they will bring these restrictions and/or lockdowns back again, if COVID-19 cases climb in the future.
- 14. Based on the facts that this was a coordinated world-wide event, with similar lockdowns and restrictions everywhere, identical or similar language from all media outlets around the world, that all Governments appeared to be blindly following the World Health Organization and repeating the same narrative over and over again, Henry's declaration of an emergency with only three alleged deaths in B.C., that nurses confirmed that our hospitals were not over-packed as Henry claimed, I readily concluded that something very nefarious was taking place that had nothing to do with health

protection.

- 15. I had hoped to learn more truths on these issues that would verify my research, and on other issues that I knew were likely to arise in the very near future. I was discouraged that there seemed to be no end in sight for this *PLANdemic* despite Bonnie Henry claiming two weeks to flatten the curve, and that the next planned assault would be the promised "vaccine"
- 16. All information in relation to COVID-19 appeared to be coming from MSM, and all displayed the same Government narrative tone, content and demeanour, repeated over and over, as if they were simply the mouthpiece for the Governments. From my perspective, it was more akin to Government sponsored propaganda than accurate news reporting.
- 17. I was very much discouraged as well by the non-threatening, if not stupid questions reporters from the MSM were asking Government officials. I was thinking of many more damning questions to ask for real information but the reporters would simply not ask any questions that would put the Government officials on the defensive or expose what they were doing was wrong.
- 18. The internet and these Lawful Protests were the only way for me to obtain accurate reporting from independent news sources that I could share and discuss with others, and I found it extremely disturbing to see how Canadians were being treated after the mandates and lockdowns were issued.
- 19. The effects of Henry's orders affected myself and my spouse directly. Misinformed and panicstricken business owners and employees were physically and verbally abusing un-masked customers on a regular basis, including myself and my spouse who regularly were compelled to argue with business employees on these issues. Even more disturbing were the actions of the RCMP and provincial police who were laying charges against people in the exercise of their Constitutional rights and freedoms, including David.
- 20. Upon my first visit to the Lawful Protests, I was relieved to see many other sane people who possessed the ability to practice critical thinking, common sense and reasoning skills.
- 21. I subsequently and ongoingly became aware of credible information from the CLEAR group and David, from presenters, the literature tables, other people and groups present there such as Vaccine Choice Canada and Action4Canada, and as part of group discussions that invariably occurred at our Lawful Protests. Some of the education I received, shared with others and do verily believe, from

these Lawful Protests, include:

- A. the futility of masks to prevent viral transmission and the reasons they don't work, from sources such as Prof. Denis Rancourt, "Masks Cause Harm"; Dr. Anthoni Fauci, "Why Face Masks Don't work"; and Canadian Superior Court-accepted mask expert Chris Schaefer in his oral presentations at the Lawful Protests;
- B. the fatal error of the B.C. Government using the PCR test and its huge false positive rate, with information on this also contained in CLEAR's brochure on masks and the PCR test, and which I further discovered by reading an External Peer review of the RTPCR test to detect SARS-CoV-2 reveals 10 Major scientific flaws at the molecular and methodological level: consequences for false positive results, of the Corman-Drosten report, in 2020;
- C. that the vaccine as it was called was really not a vaccine as I understood its normal meaning which was to have dead viruses in it to trick the body into making antibodies in the immune system, as the WHO and our Government simply changed the definition, and in reality, it was an experimental injection that modified people's DNA;
- D. that mandates are not laws;
- E. how Henry was misrepresenting the statistics by using cases instead of infections, because cases were much higher and skewed the figures;
- F. that COVID-19 had a mortality rate the same as the regular flu;
- G. that the B.C. (and Canadian) Government data for 2020 indicated that the same number of deaths as previous years were now attributed to COVID-19 while there were hardly any deaths from influenza. I don't believe this has ever occurred in history. According to statistics I was reading at the time, flu deaths were replaced by COVID deaths for that year, and we were again lied to, which my view was supported by former University of Ottawa professor Denis Rancourt;
- H. learning the stories of people who were vaccine-injured and what the vaccines did to them and their families, and how health authorities and Governments turned their backs on them when they sought help. I have talked a few vaccinated people over the past two years, including Dave Menchinton, and who appeared at the Lawful Protests to discuss his crippling injuries sustained from the COVID-19 vaccination;
- I. not one person who was ever vaccinated with the COVID-19 "vaccine" has told me they were given sufficient information, such as ingredients of the vaccine, the number of deaths and injuries attributable to the vaccine and other important information, to provide informed consent when deciding whether to be vaccinated. This really concerned me that far too may people were deciding to get vaccinated only on the Government's word that they were safe, despite the fact there were no long-term studies done on these vaccines as they were only introduced less than six months earlier;
- J. learning from the many doctors, including Dr. Hoffe, Dr. Malthouse, Dr. Nagasse and others we had speaking and whom I personally recorded, on how the B.C. and Alberta Governments and medical boards were prohibiting doctors from speaking out against the official narrative, especially under threat of termination; and prevented from honoring their Hippocratic Oath;

- K. finding out about the sexualization of children in our schools through the SOGI 123 program, encouraging them to question their own gender identity. Becoming aware that pedophilia, incest and pornography are being taught and normalized to young children;
- L. the ongoing issues surrounding planned digital ID and currencies and subsequent privacy threats and concerns;
- M. 15 minute, or "prison cities" as they are now referred to, where local Governments, including Kelowna, are structuring cities so that people do not have to travel more than 15 minutes from their homes and/or penalizing people for driving outside of 15 minutes from their homes and blocking off certain streets, thereby restricting or denying our freedom of travel;
- N. learning from David of an Ontario labour case in 2015, where Bonnie Henry was giving evidence under oath, and admitting that masks do not stop viral transmission and that she was not a supporter of them. This was one issue I wished reporters would have asked her about and they did not;
- O. that the Coronation Oath of the Monarch is part of our Constitution, and this includes the promises of the Monarch to uphold the principles of the Protestant Christian religion and our common law, and that no statute or law can violate these promises;
- P. that over 100 Canadian doctors are now dead from the COVID-19 vaccine. Even if this figure is slightly in error, that is a lot of medical doctors who took the jab and died shortly thereafter, as have many others. - 22. This was important information and education that I wanted to express to others. The Lawful Protests allowed me to fulfill my desires and intentions to do so, while simultaneously having the opportunity to hear and receive information from many other people, including the CLEAR group, David, and many individual protesters that appeared as well.
- 23. Within a week or so after I began attending the Lawful Protests on Nov. 21, 2020, Henry issued her first mask mandate, despite her evidence in the 2015 Ontario Nurses' case that they do not work and she had serious concerns about them. Both myself and my spouse were immediately mistreated in public businesses for refusing to wear a mask, and refused service in a local bank. We expressed our experiences with others and listened to their similar experiences at these Lawful Protests.
- 24. On December 10, 2020, I was suspended without pay by my employer for refusing to sign a "*Health Check Questionnaire*" which invaded my privacy, had no scientific basis for diagnosing illness, and was not part of my Employee Contract. This new rule had been enacted simply because Henry had declared an Order to enforce a Workplace Covid-19 Safety Plan. This reinforced my beliefs and wishes to attend the Lawful Protests.

- 25. I desperately needed to do something to try to warn the community about the harm caused by wearing masks and the experimental toxin that was being marketed and injected as a COVID-19 "vaccine," without Informed Consent. The Lawful Protests and Marches offered the only effective opportunity for me to reach out to the public and inform them of the truth.
- 26. It was in the spring of 2021, that my spouse was asked by a female representative of CLEAR if she wished to assist by volunteering at the table they set up to distribute information and educational materials, and she readily agreed. She has done this ever since, distributing information and educational materials on a variety of issues and from a number of groups and organizations. She too has been committed to educating people and getting information and materials out to them to show the truth in relation to COVID-19 and other freedom issues.
- 27. At the end of July, 2021, just as I was about to return to work, the unlawful mask mandate was once again reinstated in the Okanagan, whereby my employer refused to allow me to return to work without my agreeing to wear a useless mask. I did not agree and remained unemployed without pay.
- 28. In September of 2021, the Vaxpass was put in place and we could no longer go out to restaurants or any other establishment requiring that we "show us your papers." I truly felt like this is what it must have been like in dictatorial countries in WWII, or even the Soviet Union. This negatively affected our lifestyle significantly as we could no longer go out to restaurants or other social establishments. These incidents inspired my ongoing attendance at these Lawful Protests and I was even more determined to get the truth out to people in relation to the COVID-19 *PLANdemic*.
- 29. On April 23rd, 2022, I received a ticket for temporarily stopping in front of a yellow curb to unload the equipment for the Lawful Protest. I was not blocking the fire hydrant. It was the only available spot at that minute, and I immediately moved the truck and paid for parking elsewhere as soon as the truck was unloaded.

30. On December 5th, 2022, the City's Santa Bus parked at the approximate same location in front of the same yellow curb where I had stopped, but also blocking the fire hydrant, for a minimum of 45 minutes as it does every year, contrary to the stated bylaw exceptions. Large travel buses park there regularly for extended periods of time without repercussions from Bylaw Services. It is the only place to park temporarily to access Stuart Park and many vehicles do this every week. No tickets

were issued to the driver.

31. On June 4 2024, I personally witnessed a school bus also stop directly in front of the fire hydrant in the same location as I had stopped, and was there for approximately 15 minutes while the driver was waiting to pick up the students. I don't believe any tickets were issued to the driver because I did not see any Bylaw Officers do so. I have seen many others stop as well in this location even at our Lawful Protests, and were not issued a ticket despite Bylaw Officers being present across the street.

- 32. On July 30, 2022, I observed and video-recorded City of Kelowna bylaw officer Shawn O'Hanlon asking David if he had a permit for our Lawful Protest. Bylaw Officer O'Hanlon took the court case document David provided to him where the BC Supreme Court judge ruled we had a Constitutional right to protest outside, and without looking at, or considering it, put it inside the vehicle with its window open and left.
- 33. Beginning in early October, 2022, I observed that a group of people opposed to incidents and activities in Iran (the Iranians), began to protest at Stuart Park every Saturday, just after we were finished our Lawful Protests. Subsequently, they moved over to Kerry Park. These protests continued at least into March, 2023 that I am aware of, as I personally witnessed them still there. I am attaching hereto as Exhibit "D" a copy of some of the pictures that I took of them on Dec. 31, 2022.

34. During my time at these Lawful Protests, the public has always walked freely throughout the Park. They have walked on the sidewalks, through the Park, on the landing, through the protestors, and people have gone up the ramps even walked behind our speakers, and up to the Bear, and frequently children were even playing up there. Many people were roller-blading and enjoying other summer activities in the concrete area and on the other stage, and skating during the winter. We did not deter anyone from their activities, and at no time did anyone complain to us that our Lawful Protests were interfering with their use or enjoyment of the Park. Every time I travel past this Park during the week, and on weekends when we are not present, there is virtually no one there. Although some people may not agree with our message of truth, we are Kelowna citizens whose taxpayer money was used to establish this Park and we have every right to be there.

35. Though the mask mandates are presently not in effect, I don't believe that the issue is over. Bonnie Henry and the Government continually claim that they can bring them back in again in the fall, or during the next alleged round of COVID-19 cases, or any other reason. This worries me and I am forever on guard against this and continually promoting the truth that masks will not stop or prevent viruses from being breathed in.

Videotaping of Lawful Protests

- 36. I realized in December of 2020 that these Lawful Protests should be recorded for posterity. So, I became the unofficial videographer, recording and taking pictures and videos of history in the making, at all Lawful Protests (even at different locations) and Marches. I knew this would be historically significant footage, especially since MSM had been instructed and paid by the B.C. Government to completely ignore and dismiss all protesters.
- 37. My footage contains the information that mainstream media has been withholding from the public. I videotaped speeches by extremely knowledgeable, competent and well-respected experts in the Health Field, Scientific Research, Legal System, Law Enforcement, Religious Worship, Psychology, Media and Government. Many of these persecuted individuals, especially the doctors, were whistle-blowers who had the courage and integrity to stand up to government-directed forms of intimidation and expose the truth about corruption in their fields of expertise.
- 38. I wished emphatically to express to people the truth about what is happening to our Christian Pastors who, in particular were targeted with tickets, fines, arrested, thrown in jail and kept in solitary confinement for the crime of preaching the Word of God. I promoted this in discussions with other protestors and people at the Lawful Protests, and we heard information on this from David.
- 39. I video-recorded many people who attended our Lawful Protests to express their message, truth, information and/or knowledge to the public in relation to COVID-19, or even to inspire them and help them realize their political goals. Many discussed rights and freedoms issues, and others described their attempts to educate people, including B.C. Government officials. I am listing some of these people here below and a cursory review of their discussions. There will be more videos than those listed below I will rely upon that I personally recorded at the Lawful Protests.

Α.	Dr. Stephen Malthouse	Wrote a letter to Bonnie Henry in the fall of 2020, in his capacity as a medical doctor, about the reality of COVID- 19 and was ignored, and subsequently attacked by the B.C. College of Physicians and Surgeons. He was persecuted for expressing his views on the COVID-19 situation and for pointing out errors by the B.C. and Federal Governments.
B.	Dr. Charles Hoffe	Wrote to Bonnie Henry in his capacity as a doctor, expressing his concerns about the harm experienced by his patients after being vaccinated, and he was ignored and subsequently attacked by the B.C. College of Physicians and Surgeons. Dr. Hoffe as well expressed his views on the COVID-19 situation and errors by the B.C. and Federal Governments.
C.	Dr. Mel Bruchet	At Lion's Gate Hospital in Vancouver, 13 Stillbirths were recorded in a 24 hour period. When Dr. Bruchet heard this from trusted connections at the hospital, he spoke publicly about this, revealing all the excess stillbirths from COVID- 19 vaccinated mothers. Typically, there are 5-6 per YEAR. He was subsequently kidnapped from his home by police and imprisoned in a mental health ward in Vancouver.
D.	Dr. Roger Hodkinson	He is a Pathologist who has been extremely vocal about the fraud going on in the health care system and how people's lives are being endangered by their unscientific decisions. Dr. Hodkinson further spoke about his time on the front lines of the Trucker's Convoy in Ottawa, where he spent a considerable amount of time. He informed us that everything portrayed by MSM contradicted the fact that this was the most peaceful, loving and incredibly inspiring event in Canada's history. Thousands of Canadians who were there have all made this same claim.
E.	Dr. Daniel Nagasse	Expressing his disappointment with the refusal of superiors in Alta. to support the use of Ivermectin to treat COVID- 19. Dr. Nagase was fired for saving the lives of three of his patients by prescribing Ivermectin. He also exposed the explosion of stillbirths from vaccinated mothers in Waterloo, Ontario.
F.	Nurse Kristen Nagle	She discussed the false lies from our public health officials about the alleged backlogs in our hospitals, confirming that this did not exist, as well as her experiences from patients in the hospitals where she worked, until she was terminated for refusing to comply with vaccine and mask requirements.
G.	Nurse and veteran Sean Taylor	Spoke about the COVID-19 hoax from his experience working at Kelowna General Hospital and in Boundary District Hospital in Grand Forks, until he was terminated for speaking publicly about this. Also, he ran for political office in the last Federal election and promoted this at the

Lawful Protests.

H.	Nurse Andrea Henders	A former nurse at Kelowna General Hospital, was hired in the perinatal unit in Labour & Delivery in May 2020 and then terminated in October 2021 for refusing to be vaccinated. Andrea expressed to us the truthful facts of what was actually going on at the hospital, and that it was not overbooked and nurses were not overworked as the B.C. Government and Bonnie Henry alleged.
I.	Erica, Kelowna Unity Group	Promoting and distributing medical opinions in what is called the " <i>Doctor's Package</i> ", from over 100 health care professionals in the Okanagan who wrote two very detailed letters to Bonnie Henry in the fall of 2021 explaining the facts about COVID-19 and how inappropriate the Health and Safety Measures were for the population. They were ignored. The health professionals have remained anonymous for fear of reprisal.
J.	Ted Kuntz	Vice-President of Vaccine Choice Canada (VCC), who regularly spoke and expressed inspiration as well as updates on cases and successes around the country in relation to vaccine injuries/deaths, their ingredients, information about the vaccine companies and Big Pharma, and legal and political actions that VCC was taking.
K.	Chris Schaefer	A court-approved mask expert explained how masks cause harm and do not and cannot prevent the flow of viruses. He distributed his mask brochure as well and I know we continue to do so.
L.	Anita Krishna	A former newscast director at Global News in Vancouver, she was ousted from her position when she started questioning and speaking out against the false and deceptive Covid-19 media narrative. She has become an outspoken whistle-blower exposing the corruption in Canada's mainstream media.
M.	Keith MacIntyre	Used to do the scientific modeling for the U.S. Center for Disease Control and described how these models are unreliable and further, they are now being manipulated to mislead the public. He is a former leader of the BC Libertarian Party who ran for election in political office and provided this information.
N.	Tanya Gaw	Tanya is the founder and leader of Action4Canada. Expressing herself and was promoting Christianity and her opposition to the COVID-19 lockdowns and restrictions with her Notices of Liability, and court action in the BCSC, as well as opposition to school boards and their promotion of child porn in our schools. Tanya further provided

Christian messages of hope, support and reliance on the Word of God in her messages and actions.

Danielle is the organizer of the Vancouver Lawful Protests which drew over 10 000 protestors opposing the COVID-19 lockdowns and restrictions. Expressing her views on COVID-19 and messages of inspiration.

P. Kari Simpson Kari is the Executive Director of Culture Guard. Kari spoke at our Lawful Protest as part of the Doctor's Tour: "Justice for the Vaccinated" to give victims across Canada a voice. She has been touring with Dr. Malthouse and Dr. Hoffe, who have been speaking in multiple communities to help educate the public and collect their stories of Governmentcaused harm via this toxic injection. On Oct. 21, 2021, she provided a powerful letter to former Attorney General of BC David Eby.

Q. David Lindsay Appeared at virtually every Lawful Protest. Each week David expressed his views and updated information in relation to COVID-19 and other rights and freedoms issues. David regularly promoted the Word of God and explained legal and Constitutional issues such as the Coronation Oath as part of our Constitution and the supremacy of God therein; how laying criminal charges works and urging people to exercise this right against criminal employers and government officials; how disclosure law works if you are charged with an offence; the true interpretation and explanation of COVID-19 orders, mandates and legislation; providing true statistics on COVID-19 and how Bonnie Henry's statistics were misleading and false; medical information in relation to COVID-19 including how the PCR tests work, mask usage and statistics to show Bonnie Henry was lying; promoting others to express themselves on stage; as well as providing inspiration and the importance of courage in standing up for our beliefs, our rights and freedoms and our true common law.

R. Dave Mechinton Who was seriously injured after getting vaccinated and discussed his injuries and how they have affected his life.

- S. Dozens of individual speakers, including children, to express themselves on these and other issues, including teachers, scientists, concerned parents, people who lost their employment for refusing to be jabbed or wear masks, the vaccine-injured and people who suffered loss or injury to loved ones from the vaccines, representatives of Police on Guard for Thee, and many others, all who had messages they expressed and conveyed on the stage to all protestors in attendance.
- 40. I further promoted the messages these speakers were conveying by distributing my videos first on Facebook and then exclusively on Telegram for people to see. The censorship became so prevalent

on all the online mainstream platforms, anything that depicted truth and facts which countered the Government narrative was, and continues to be, banned and removed.

- 41. I have videotaped several occasions when we had protest marches (Lawful Marches) in downtown Kelowna. The RCMP regularly provided traffic control. These Lawful Marches were intended to and did assist us to speak to the community and distribute informational and educational brochures to people, especially on Bernard Ave., where there was a large number of pedestrians and business customers on the street.
- 42. I personally recorded the following videos that David references in his Affidavit #1, that I provided to him:

43. I personally witnessed a group of protesters at Kerry Park to save old growth forests on June 5, 2021. I am attaching hereto at Exhibit "F" true pictures I took of these protesters, including when they were doing their protest on Hwy 97.

- 44. I assisted to set up the sound equipment and my own camera equipment for each Lawful Protest. I was aware that many people were having difficulties hearing from the sidewalk area or even those who were protesting on the side of Water St. facing the Park. So, I tried to adjust the speakers, at David's request, so that it was only loud enough to permit those close to the street to actually hear what was being said. I also ensured that the speakers were facing forward toward City Hall and not toward the skating rink or boardwalk areas, so as not to disturb those people as best we could. At no time did we use any electrical or other services from the City of Kelowna.
- 45. At no time did anyone, including Bylaw Officers, make any mention of any concerns to myself or my spouse who was volunteering at the CLEAR tables, nor any of the several people I inquired of, in relation to the use or volume of sound from the sound equipment being used. The only complaints I heard were from people at the back who were unable to hear due to low volume.
- 46. The Lawful Protests continue and remain relevant today as more and more people become

disenchanted with television, radio and newspaper propaganda, more vaccine injuries and deaths continue to be made known and people are looking for answers and are seeking information from us in relation to COVID-19 and new rights and freedoms issues. Many people at these Lawful Protests told me they were getting more upset with Government official lies as well as all the draconian bills currently being passed in Legislature and Parliament.

- 47. There were no bylaw tickets served upon David at any time until August/September, 2021. We had discussions with Bylaw Officers in late 2020 and into 2021, and they said we had a right to be there but we just could not use City services without a permit.
- 48. When the Bylaw Officers first started serving tickets upon David, it was around that time that David talked to me and informed me that one of the Bylaw Officers told him that their management had been contacted by the Province and told to start handing out tickets to try and close down the Lawful Protests.
- 49. One objective I have by attending these Lawful Protests, is to share and express my concerns with others about what our Governments have done over the past three years and their results, including increases in divorces, suicides, families and friendships being destroyed, seniors have been literally murdered under the guise of health care and prevention of COVID-19, and the ongoing psychological warfare by our Governments and media.
- 50. Another objective I have is to share our information with Government officials such as our Mayor and Council, MLA's and MP's to acknowledge our concerns and communicate with us, which is the job they were all elected to do. Instead, they have been ignoring us, locking their office doors, refusing to accept information, targeting and harassing us through Bylaw Services, encouraging us to participate in a medical experiment, preventing access to public services and health care if we don't, and creating a two-tiered society based on personal medical choices.
- 51. These Lawful Protests were necessary for me to express my beliefs, thoughts and opinions on these issues, topics, ideas, and concerns of mine, to others, and to hear same from others.
- 52. Many protesters have told me that these Lawful Protests have resulted in many of them feeling like this is their family, because so many people either believed the Government lies and misrepresentations, or simply didn't care, including their own family members.

- 53. In the face of imminent future threats to my rights and freedoms, and privacy, it is important for me to continue to appear at these Lawful Protests. I personally witnessed people on the streets and walking through Stuart Park who were either interested in our messages or became interested as a result of our messages. Many people took our brochures and handouts from various people during our protest marches and handing them to people on the boardwalk.
- 54. I am very much concerned that if our Lawful Protests are cancelled in the downtown area, there will be no place for me to go to share in solidarity our messages to the public, especially that has been so effective as Stuart Park.
- 55. Stuart Park and its beautiful area, has had a huge and positive energy among all people coming here. This is something that, because of its location, no other place in the City can provide.
- 56. David informs me, and I know from talking to hundreds of people, that many, many people are worried about not being able to assemble at this location for our Lawful Protests. There is a major fear in people, myself included, that the Government is simply acting as a form of Communist Government in stifling our Lawful Protests against its actions that we strongly disapprove of.
- 57. I make this Affidavit true and correct in support of the Response to the Petition of David Lindsay, and in further support of the Constitutional Challenge integrated therein and for no improper purpose.
