APPEAL

THE APPELLANTS APPEAL to the Federal Court of Appeal from the Judgment of The Honourable Mr. Justice Mosley (the "reviewing Judge") dated January 23, 2024, Federal Court File Docket T-306-22, by which the Reviewing Judge dismissed the Appellants' application for judicial review of the decisions by the Governor in Council to declare a Public Order Emergency pursuant to s 17(1) of the *Emergencies Act*, RSC 1985, c 22 (4th Supp), and to promulgate the *Emergency Measures Regulations*, SOR/2022 and the *Emergency Economic Measures Order*, SOR/2022 (the "T-306-22 Judgment").

THE APPELLANTS ASK that the T-306-22 Judgment be set aside and that they be granted their costs of this appeal and the proceedings below.

THE GROUNDS OF APPEAL are as follows:

1. The reviewing Judge erred in denying the Appellants standing.

2. The reviewing Judge erred in finding that the Application was moot.

3. The reviewing Judge erred in finding that the temporary measures (i.e. the *Emergency Measures Regulations* and *Emergency Economic Measures Order*) were not incompatible with the *Canadian Bill of Rights*, SC 1960, c. 44.

4. The reviewing Judge's decision not to award the Appellants costs was an error in principle and/or is plainly wrong.

5. The reviewing Judge erred in fact and in law, misapprehended the evidence, and failed to observe the principles of natural justice.

6. The Appellants rely on sections 18.1 and 27(1) of the *Federal Courts Act*, RSC 1985, c F-7 and Part 6 of the *Federal Court Rules* SOR/98-106.

7. Such further and other grounds as counsel may advise and this Honourable Court permits.

The Appellants propose that this appeal be heard at Ottawa.
