In an incredible turn of events today, Dr. Hoffe's lawyer Lee Turner announced tonight on BC Rising, with Erica, that the College of Physicians and Surgeons has dropped all charged against Dr. Hoffe, who stood courageously against the College for over three years. Next Supreme Court Appeal Hearing Date:

February 10, 2025

9:00 a.m.

On Nov. 29, I appeared also before Justice Wilson, for a case management hearing to determine how my appeal itself, will proceed.

It was determined that I will file a Constitutional Challenge to the transcripts fees statutes and regulations by the end of the year, including the basis for same, and relief I will be seeking. I will post this on our website when it is complete, along with the response from Jessica Patrick for the Attorney General in Victoria, who will be dealing with this matter.

This is merely a case conference hearing to determine how the remainder of the appeal will proceed. There may be another one or two in the future as well.

The Crown recently filed its response to my Challenge on the Transcripts Extortion Fees they are charging for appeals.

They continue to want another \$9-10K for the Transcripts in my appeal!

I am trying to do these myself and have them accepted by the Court to avoid fundraising, however, this has proven to be extremely time consuming. I have about another three days to transcribe, and then have to ask the Court to accept them.

A hearing date will likely be set on this Challenge on Feb. 10 and I will keep you updated.

Monday, April 14, 2025

To continue hearing my application to have the probation order

Kelowna before the BC Court of Appeal (three judges) in May,
2025.

I am required to file my Factum on Thursday, Feb. 6, and am
rushing to get this done.

A decision on the sentence to be imposed on Pat King will be delivered by the Judge at the Ottawa Courthouse on Friday, February 7, this week.

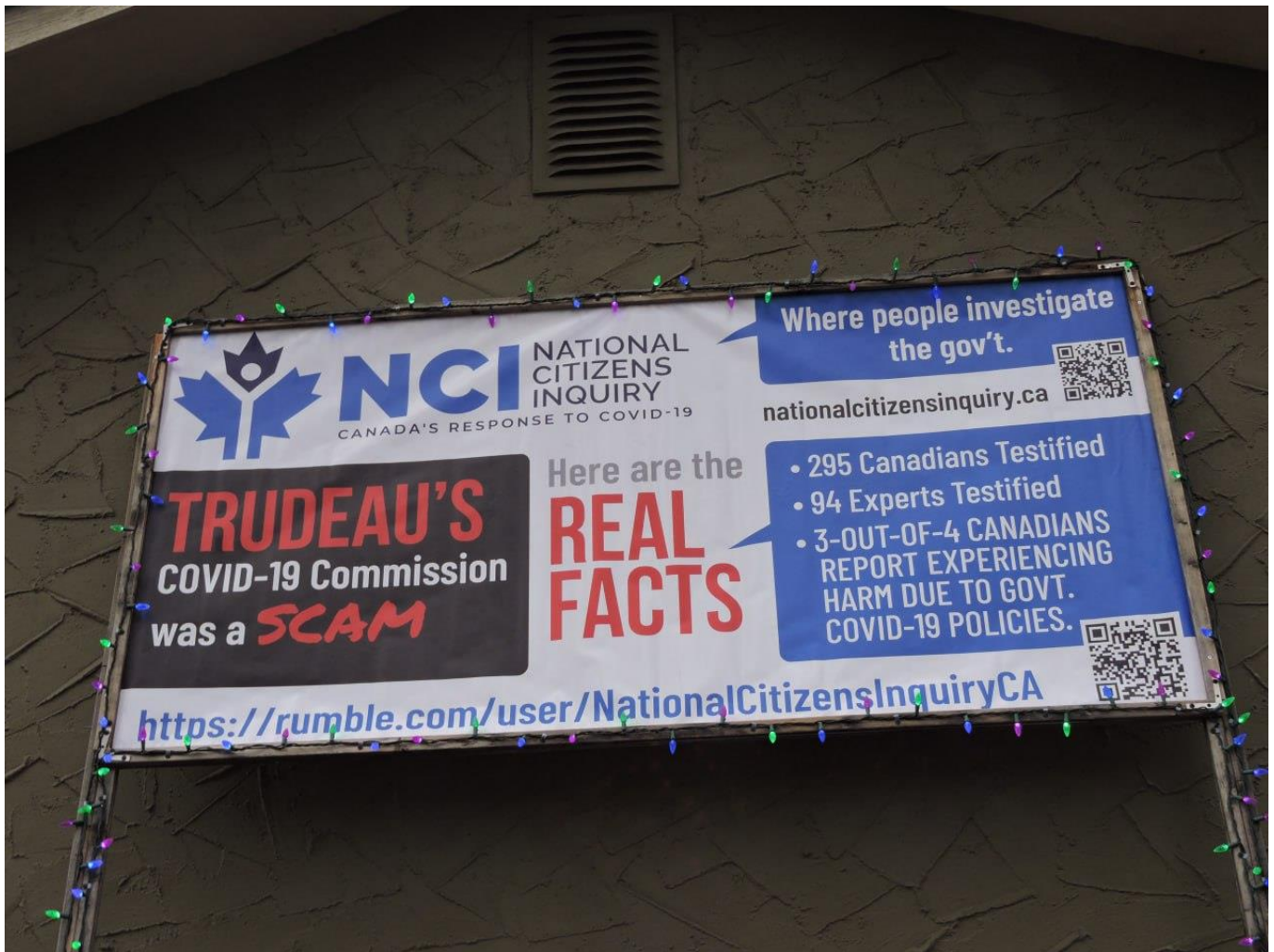
Crown was seeking up to 10 years, and King was asking for time served up to a maximum of two years.

In January of 2023 Action4Canada created a [petition](#) and brought awareness to a matter involving Tyson Cook, aka drag queen Frieda Whales, who was set to perform/read to children at a local library. We learnt that in his spare time, Mr Cook created videos depicting murders, cannibalism and Satanic-like rituals and his social media posts consisted of sexually vulgar and profane language ([learn more here](#))

In addition we discovered that Mr Cook also works with vulnerable special needs children as a certified [Education Assistant](#) (EA) in the Kelowna School District as well as with autistic children for AutismBC.

Our petition demanded that the City of Kelowna STOP using taxpayers' money to fund Drag Queen Story Hours, and that the School District reassess Mr Cook's suitability as an EA.

According to the BC Commissioner for Teacher Regulation, School Districts as well as the public have a "[Duty to Report](#)" if there are concerns regarding breaches of Professional Conduct, on or off duty. Although Mr Cook is only an EA he must be held to the same standard when working with children. It is important to note that in Coquitlam, BC in July 2023 an [EA was fired because she was in violation of the Code of Conduct](#) for running a social media account offering paid adult content.

Despite almost 19,000 people signing the petition, the Kelowna School Superintendent, Kevin Kardaal, did nothing and gave Mr Cook a free pass.

Now, two years later, Mr Cook has decided to file a vexatious and frivolous [Notice of Civil Claim](#) accusing Action4Canada of publishing "*statements online that are harassing, disparaging, and defamatory*"...and that "*these publications contain obviously false content*". However, all of the content was created by Mr Cook, not A4C. We merely reported on and posted what he had already made public, as is our duty to do so.

Action4Canada has retained lawyer [James Kitchen](#) to represent us. Since we are fighting to protect children across Canada this claim involves everyone so we would be very grateful if you would [please donate](#) to the legal action fund today.

India: advertising about banning Bitcoin

Kuwait: Forced over 1 million citizens to hand over their bio-metric data (including fingerprints) and suspending services if they do not do so, including withdrawing or transferring money.

Date for this was Sept. 30.

35 000 bank customers suspended from using bank services

England: Bank England is preparing to force digital currencies if the banks do not do so.

93% of Central Banks in the world are working on a CBDC – this is truly frightening.

USA: House of Representatives voted to pass a bill, The Anti-Surveillance State Act, 216-192, prohibiting the Federal Reserve from issuing a CBDC. It is concerning however, many still voted against this.

Florida: Passed a law banning CBDCs!

Support Protection of Cash Now – in Parliament!

Bill C-400

SUMMARY

This enactment provides for the development and implementation of a framework to ensure that cash continues to be available throughout Canada.

It also amends the *Currency Act* and the *Bank of Canada Act* to remove the Governor in Council's power to call in coins and notes. Finally, it amends the *Bank of Canada Act* to prohibit the Bank of Canada from issuing a digital form of the dollar.

The Bank of Canada (B of C) has recently announced plans to suspend introduction of a Central Bank Digital Currency (CBDC) to the public.

While this may sound victorious on its face, and there is much positive to say when such plans are shelved or put on hold, please remember the use of the word "*suspend*" as opposed to "*cancel*".

Has the B of C simply decided to wait on the outcomes and research from other countries and then simply tag along?

In this past summer, the B of C was recommending Canada provide its own CBDC for digital payments. This apparently has been suspended or now put on hold. We can only hope for some permanency to this decision.

We need a Constitutional amendment that 100% absolutely provides for the mandatory use and acceptance of cash for all transactions – in any amount. So, if you wish to pay \$1 000 000.00 for a house in \$100/bills, you should be allowed to so do. That is privacy.

Conversely, Google has announced that the Google Wallet can now function as digital ID, based on the selling point of course, of convenience to the exclusion of all privacy. Once privacy is lost, so is freedom.

"Imagine starting a vacation like this," Google Wallet executive Alan Stapelberg wrote in a [blog post](#) last week. "You arrive at the airport and breeze through security by tapping your phone to a reader, scanning your boarding pass and ID. While waiting to board, you grab a drink at an airport bar, tapping your phone to prove your age. When you arrive at your destination, you find your rental car and leave the lot without stopping for an in-person ID check because you already provided the necessary information in the rental car app. You check into your hotel online and your key is issued straight to your digital wallet. You do all of this with your phone — no physical wallet required."

The Bank of Canada is admittedly planning for digital currency.

It claims that it will not replace cash – BUT – and here is the caveat, it will continue to use cash “notes for as long as Canadians want them.”

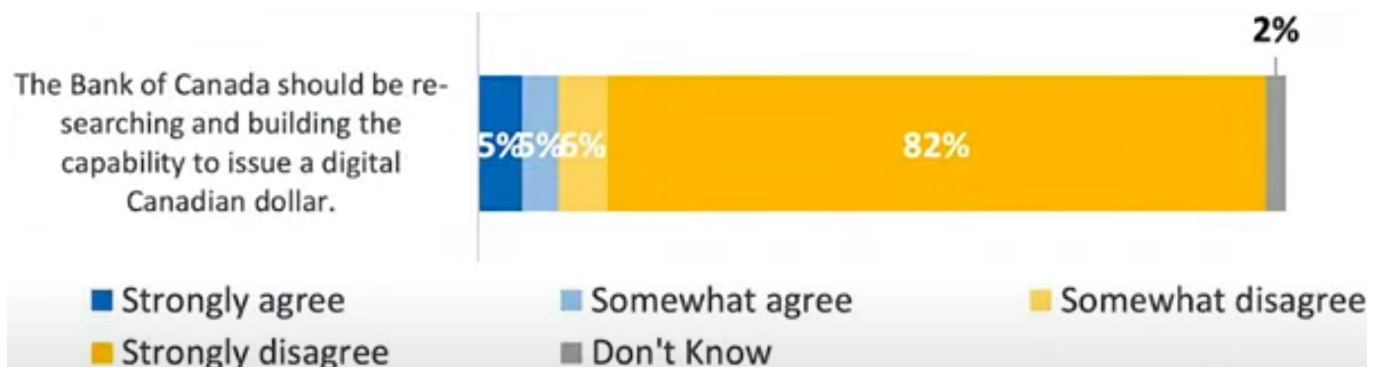
