

FALSIFIED ASSAULT CONVICTION APPEAL

Update - Success:

I will be back in court this week (Dec. 1) to set dates next year for the actual hearing of my appeal, and all issues I am raising.

Some include:

Judge Heinrichs was clearly biased against me

s. 265 of the *Criminal Code* is overbroad and vague to permit mere touching to constitute a criminal offence

Judge Heinrichs erred in not letting my transcriber do the transcripts for my *Jordan* Application for delay – at this time over three months late

The *RCMP Act* is *ultra vires* Parliament - policing is a Provincial matter

The security guards, on video, assaulted me

Security Manager Greg Smith lied to the police and in court

On Monday, November 3, 2025, J. Wilson ordered that Twyla can produce my Transcripts required for this appeal, despite having no contract with the Province to do so!!!!

This is a major victory in opening the door to having future transcribers produce Transcripts for appeal purposes, even at no cost to the accused!!

This is the foot in the door to the eventual judicial recognition that we are entitled to Transcripts as of right on appeals. This remains to be determined in some other case, but it will be raised again at some point in the future.

Meanwhile, it is a good victory that Twyla, a certified court transcriber who also believes in freedom, can produce my Transcripts for this appeal. The actual appeal date will not be set until later this year or in January, but it will not be till likely in the summer of 2026.

Thanks to God for this important success!

**Probation Order suspended till appeal is heard –
David can now host the Freedom Rallies and publicly
discuss this trial!**

At sentencing last year on the falsified assault charges against me, J. Heinrichs imposed a completely unreasonable two-year probation order, prohibiting me from publicly talking about the security guards involved in the incident, including Greg Smith, the Interior Health security officer who lied directly to the police that I was causing a disturbance in support of his one-month ban against me from entering the IH building on Doyle St. in Kelowna. All of which we have on video, thanks to Leo's diligence and dedication.

In Court recently, the Supreme Court Justice agreed to suspend the probation order until the appeal is heard sometime next year.

And this further allows me to continue our Freedom Rallies again!

NOTE: The City of Kelowna has once again started issuing me tickets for holding our Constitutionally protected Freedom Rallies. Their position is that we need a licence to do so. This case will likely wind up, once again on freedom of expression, in the Supreme Court of Canada.

IMPORTANT LEGAL UPDATE **FREEDOM OF EXPRESSION CASE**

Dear Freedom Supporters:

We want to provide you with a critical update regarding our legal battle for freedom of expression.

Continuation of the hearing for our SLAPP application has concluded in late August.

Justice Hardwick has reserved judgment in this case.
There is no set date for the release of her judgment.

Kelowna filed a Petition to obtain an injunction to ban our rallies throughout the entire downtown Kelowna area, the most effective areas in the City.

In turn, we filed what is known as an anti-SLAPP application pursuant to the *Protection of Public Participation Act*. The acronym (SLAPP - Strategic Lawsuit against Public Participation), says it all – the Petition is a SLAPP

action intended to prohibit our public participation at Stuart Park exposing gov't corruption and lies. We applied to have it struck.

Our anti-SLAPP Application: A Strong Legal Defense

Our anti-SLAPP Application is incredibly detailed and well-prepared. As the legal maxims state: "*Fraud lurks in generalities*", and, "*the details make all the difference.*"

The City's strategy is clear:

1. Ignore Constitutional law and attempt to redefine protesting as a regulated activity.
2. Gloss over key legal principles and hope the courts accept their broad, unfounded claims.
3. Bylaw us out of existence—forcing us away from public spaces and out of the public eye.

But we refuse to be silenced.

We knew we had to be meticulously prepared, with extensive evidence and legal arguments to counter every false claim. And we are prepared.

The Broader War on Free Speech

This case is not an isolated attack—it is part of a coordinated effort to suppress free expression across Canada, particularly in British Columbia and Alberta.

- Online censorship is expanding.
- Private interest groups, funded by the government, are targeting businesses that support free speech, threatening them with boycotts and false accusations. Many businesses break contracts with us at the last minute out of fear.
- Municipal governments are being weaponized to push freedom advocates out of public spaces.
- And most recently under the Communist Liberal Government, ongoing refusals to permit certain media outlets into their press releases and government functions, to ensure only Liberal Government supported media is allowed in.

Their tactic is simple: Out of sight, out of mind. If they can erase us and our messages from public view, they believe they can stifle dissent.

**Next email will have MORE survey results to share - here are the original first results so far:

Survey results so far with responses from only 25% of BC Psychologists so far: Survey context:

- There are 1,579 psychologists in BC.
- Approximately 388 completed the survey — many others not likely aware of the issues.

Personal & Professional Risk:

- 262 respondents (67.53%) are extremely or very concerned about personal/professional risk under the HPOA.
- Concerns include: expanded misconduct definitions, harsher disciplinary processes, higher fines, possible prison, reputational harm, and greater investigatory powers.
 - Impact on Professional Wellbeing:
 - 371 respondents (95.61%) are concerned or very concerned the HPOA will harm their wellbeing (stress, job satisfaction, mental health).
 - Leaving or Reducing Practice:
 - 262 (67.53%) are likely or very likely to stop practising in BC, retire early, or move to another jurisdiction.
 - Among 126 intending to stay, 45 (35.71%) expect to reduce or change caseloads.
 - Leaving the Profession:
 - 189 (48.71%) are likely or very likely to change careers or retire earlier than planned.
 - Defensive Practice:
 - 365 (94.1%) expect to engage in more defensive practice (driven by risk avoidance rather than client needs).
 - Impact on Clients & Collaboration:
 - 361 (93.04%) expect decreased patient trust.
 - 370 (95.36%) expect decreased client willingness to share sensitive information.
 - 333 (85.82%) expect poorer client mental health outcomes.
 - 228 (58.76%) expect to consult less often or with fewer colleagues.

Digital ID card scheme will confirm right to work

Too easy to slip into shadow economy, says PM

Too easy to slip into shadow economy, says PM

Every worker in Britain will require a government-issued digital ID card in an attempt to stop illegal immigrants from “slipping into the shadow economy” and driving down wages, Sir Keir Starmer will announce today.

In an initiative to tackle illegal migration and the threat posed by Reform UK, the prime minister will announce his backing in principle for a compulsory scheme to verify a citizen’s right to work in Britain.

In a speech to be given in central London, Starmer seeks to set out a more assertive case for Labour amid criticism of his leadership and speculation over his future before the party’s conference this weekend.

The government wants to introduce digital IDs as proof of the right to work and to make it easier for people to access public services. The approach is likely to be modelled on Estonia, where people use a unique digital ID to register births, marriages, divorces and deaths, to access bank accounts, vote and book GP appointments.

The plan risks prompting a political row after Nigel Farage’s party warned that it represented an attack on “the freedoms of law-abiding Brits”.

Starmer says in the speech: “For too many years it’s been too easy for people to come here, slip into the shadow eco-

nomy and remain here illegally. It is not compassionate left-wing politics to rely on labour that exploits foreign workers and undercuts fair wages.”

The prime minister is expected to use the speech to intensify his rhetoric over the threat posed by Reform UK, accusing Farage of pursuing the “politics of predatory grievance” and “preying on the problems of working people”.

He also says that social media has created “an industrialised infrastructure of grievance” on people’s phones, creating a worldview “that is miserable, joyless and demonstrably untrue”.

Linking Farage to protests organised by hard-right groups in London earlier this month, Starmer says that the rise of right-wing populism had “its most poisonous belief on full display ... just a week or two ago. There is a coming struggle, a defining struggle, a violent struggle, for the nation.”

In a stark warning of the risk of political violence, he adds: “You don’t need to be a historian to know where that kind of poison can lead.”

The prime minister seeks to present Labour as a more optimistic alternative offering the “politics of patriotic renewal”. He says this means “building a better country brick by brick, from the bottom up” and “difference under the same flag”.

Under Labour’s plans, anyone starting a new job would be required to “show” their digital ID, which would be checked against a central database of

those entitled to work in the UK. This ID would be compulsory for workers but not for other adults, meaning pensioners would not have to apply for one.

Britain is the only country in Europe apart from Ireland without a form of ID card. Public opinion has been largely supportive of them for some time, but Starmer was understood to be sceptical amid concerns about civil liberties. He is said to have been won round after warnings from senior figures, including President Macron, that the UK needs to tackle “pull factors” fuelling the small boats crisis.

Starmer conceded that for years Labour “did shy away from people’s concerns around illegal immigration”, writing in *The Daily Telegraph*: “It has been too easy for people to enter the country, work in the shadow economy and remain illegally ... it is not compassionate left-wing politics to rely on labour that exploits foreign workers and undercuts fair wages.”

Kemi Badenoch, the Tory leader, said the plan was “a desperate gimmick that will do nothing to stop the boats”.

Q&A

Why is the prime minister proposing this now?

Starmer is understood to have overcome his initial scepticism after concluding that digital IDs would help deal with illegal immigration.

Don't immigrants already have to have electronic visas?

Yes, but as British citizens are not required to have ID, not having one cannot be used as proof that someone cannot work. Employers are required to ask for documents such as passports or birth

certificates, but the verification of such checks is not routine.

Is this purely about illegal immigration?

That is the main driver, but it is hoped that the ID system will also deal with benefit fraud.

What are the practical advantages?

Ministers hope to sell the policy as a way to ease dealings with the state. Advocates say it makes sense, while most people give away their data online in return for convenience.

Will the police or other officials be able to demand to see your papers?

This is not the intention,

but it remains unclear who besides employers would be entitled to check the IDs. Critics say the scheme's scope would expand rapidly.

Do people support this?

Polls consistently show a majority of voters are in favour, with Labour and Tory voters most supportive. But Reform voters are significantly more sceptical.

Didn't Labour try to introduce this before?

Tony Blair's government proposed a voluntary scheme but the policy provoked divisions over plans to make ID cards compulsory. The coalition government cancelled the scheme.

India: advertising about banning Bitcoin

Kuwait: Forced over 1 million citizens to hand over their bio-metric data (including fingerprints) and suspending services if they do not do so, including withdrawing or transferring money.

Date for this was Sept. 30.

35 000 bank customers suspended from using bank services

England: Bank England is preparing to force digital currencies if the banks do not do so.

93% of Central Banks in the world are working on a CBDC – this is truly frightening.

USA: House of Representatives voted to pass a bill, The Anti-Surveillance State Act, 216-192, prohibiting the Federal Reserve from issuing a CBDC. It is concerning however, many still voted against this.

Florida: Passed a law banning CBDCs!

Bruce Cain -- "Of all the various globalist agendas -- mass immigration, forced vaccination, Smart Meters, 5G, etc. -- there is no greater threat to humanity than a global digital currency. I would go so far as saying it heralds in the end of human civilization and the beginning of a dystopian

It is important to understand that a Digital ID is a prerequisite to a Digital Currency (CBDC) as you first need to uniquely identify each human slave in a manner that can't be counterfeited. So while a Digital ID may include your Social Security Number it will go much further. Your Digital ID will also include things like your fingerprints, your DNA, an Iris Scan, a Facial Scan. It will be designed so there is absolutely no way to hack the system and no possibility of duplication."

The Bank of Canada (B of C) has previously announced plans to suspend introduction of a Central Bank Digital Currency (CBDC) to the public.

While this may sound victorious on its face, and there is much positive to say when such plans are shelved or put on hold, please remember the use of the word "*suspend*" as opposed to "*cancel*".

Has the B of C simply decided to wait on the outcomes and research from other countries and then simply tag along?

In this past summer, the B of C was recommending Canada provide its own CBDC for digital payments. This apparently has been suspended or now put on hold. We can only hope for some permanency to this decision.

We need a Constitutional amendment that 100% absolutely provides for the mandatory use and acceptance of cash for all transactions – in any amount. So, if you wish to pay \$1 000 000.00 for a house in \$100/bills, you should be allowed to so do. That is privacy.

Conversely, Google has announced that the Google Wallet can now function as digital ID, based on the selling point of course, of convenience to the exclusion of all privacy. Once privacy is lost, so is freedom.

"Imagine starting a vacation like this," Google Wallet executive Alan Stapelberg wrote in a [blog post](#) last week. "You arrive at the airport and breeze through security by tapping your phone to a reader, scanning your boarding pass and ID. While waiting to board, you grab a drink at an airport bar, tapping your phone to prove your age. When you arrive at your destination, you find your rental car and leave the lot without stopping for an in-person ID check because you already provided the necessary information in the rental car app. You check into your hotel online and your key is issued straight to your digital wallet. You do all of this with your phone — no physical wallet required."




